# PROCLAMATION DECEMBER 2015 - ZONING, PLANNING AND LAND INFORMATION AND METROPOLITAN TRANSPORTATION PLANNING MONTH

WHEREAS, the staff of these departments assist and advise individuals, businesses, professionals and governmental communities by uniformly administering the zoning, floodplain, shoreland, subdivision, telecommunication, nonmetallic mining ordinances, and consistently carrying out the provisions of the comprehensive land use ordinances; and, WHEREAS, they coordinate land information systems for the assessment, taxation, mapping, building permits, planning and the educational needs of the public and private sector, one of which is the county land records website; and, WHEREAS, they help provide a safe and efficient transportation system plan, obtaining transportation funding, which is maintained and funded partly through Wisconsin, Minnesota and federally required metropolitan transportation planning department. NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board does hereby proclaim the month of December 2015 as Zoning, Planning and Land Information and Metropolitan Transportation Planning Month and urges all residents to join in recognizing the valuable contributions of the staff dedicated to promoting the public health, safety and a property tax base through encouraging planned and orderly land use development.

- Review of Comprehensive Planning Process Planner Charlie Handy
  - o La Crosse County has 18 municipalities and all have comprehensive plans completed and many have recently updated those. The County plan was adopted in 2008 and is in the process of being updated. The LAPC completed Coulee Vision 2050 in 2014 and is currently in the implementation phase. MRRPC completed a Regional Comprehensive Plan in 2015, "Rising as a Region".
  - The comprehensive plan contains 11 elements and planning consistency is required between plan and official mapping, subdivisions, zoning ordinances, and shoreland zoning. The PRD Committee uses the Comp Plan every month.
  - Planning goals include efficient development patterns, transportation choices, integrated, efficient and economical transportation system, adequate supply of land to meet market demand, promote economic development, and balance property rights with community interests.
  - Key issues to address with intergovernmental cooperation include boundaries, coordinate planning, development and decision making, joint planning areas, explore shared services, involve school districts, consider revenue sharing, and regional economic development. Current efforts include boundary agreements between La Crosse and Campbell, Onalaska and Holmen, and Onalaska and Medary are in the process along with La Crosse and Shelby.
- Coulee Region Transportation Study Update Presented by Andy Winga, Angela Adams, and Steve Flottmeyer of the DOT.
  - o The Coulee Region Transportation Study; Planning & Environmental Linkage (PEL) is the federal highways process to evaluate many options and eliminate ones that don't meet the needs. It is a year long study of long term transportation needs in the Coulee Region and the process is used to narrow the number of alternatives before the project development process. It involves a very transparent process with large numbers of meetings and local participation. The Coulee Region is being studied due to high crash rates, bike/pedestrian accommodation needs, transit needs, motor vehicle congestion, deteriorating infrastructure, no current transportation plan, and community resolution of support for study. The desired outcome of the study is to improve reliability and safety for all modes, overall plan to address infrastructure needs, minimize impact to Coulee Region, be compatible with

- other area plans, broad spectrum of stakeholders support, and to limit the number of strategies to move forward to next phase.
- o The Coulee Region Transportation study came up with goals and objectives. The study process included a work plan, data collection and strategy development, evaluation, refine, and then the final report will be presented. There has been over 80 public involvement meetings with over 1400 total attendees and over 700 written comments. Several plans have been discarded and some plans are moving on in the process. The next steps include a final public involvement hearing on January 27-28, 2016 with a complete final report expected in March 2016. There will be a transition into environmental process with reduced number of strategies.
