COMMUNICATIONS AND ANNOUNCEMENTS:

County Board Chair Report - Tara Johnson

- WCA Recognition of Jane Klekamp Chair Johnson announced the presentation to Jane Klekamp for an award from the WCA for a Friend in County Government.
- Supervisor Conference Reports
 - Supervisor Burke announced on Monday, October 19th at 6 PM at the Pump House, there will be a conversation with local artist on how to be a more supportive community for artist. There will also be a tourism conversation and hospitality job fair on December 3rd.

- Supervisor Hampson asked all attendees of the WCA conference to make a small statement about what you learned at the WCA conference. Oktoberfest in the Capital doesn't have many people going and is encouraging Supervisors to sign up. This will take place on October 21st. Supervisor Doyle and Supervisor Holtze also encouraged Supervisors to attend as it is a great opportunity to speak with legislators and a lot of other people. The assembly will be in session on that date as well.
- Supervisor Kruse attended a Public Health Legislative Hearing on issues that impact public health.
- Supervisor Schroeder announced the Freedom Honor Flight this Saturday with the plane leaving at 7AM and return at 10PM.
- Supervisor Hoffman mentioned that an invasive species, water lettuce, was found in Lake Onalaska. Several Volunteers have been working to remove it.

Administrator Report - Steve O'Malley

- Summary of Benefits Administrator O'Malley noted that Supervisors received a packet with benefits for employees that they do not qualify for but La Crosse County is required by law to provide to you.
- Overview of High Deductible Health & Dental Plans
 - Recommended premium increase: The County has absorbed the increase over and above the plan changes. There will be small changes in contribution, small premium increase, and HRA changes are necessary to offset the costs.
 - There have been no premium increase for 5 years. Premiums for January 2016 (2% increase); \$735/single and \$1800/family. 88% of premium paid by County and 12% paid by employees. Single contribution will be \$44.10/check and \$108/check for family contribution. In-network deductible will be \$1250/single and \$2500/family. The HRA fund will receive \$250/single and \$500 family plus \$100 for participation in Health Assessment. In-network deductible will then be \$900/single and \$1900/family. 2015 HRA decreased by half and Health Assessment decreased from \$250 to \$100. There are no plan changes for 2016. Max out of pocket will be \$1900/single and \$3900/family.
 - Potential changes in the future include HRA contribution based on wellness outcomes, pharmacy network may be revised to reflect a limited network and/or removal of certain pharmacies, select formulary for pharmacy to restrict selection to ensure costs effective use, and specialty pharmacy copay may need to increase.
 - We need to continue to plan for Healthcare Reform compliance and plan design modification to avoid Cadillac Tax. All money (including HRA) contributed by the employer and employee count for the Cadillac Tax.
 - There will be a small increase in dental premiums but benefits will remain the same. Total premiums will be \$36/single and \$105/family or \$3.96/paycheck for single and \$23.10/paycheck for family.
- Neighborhood Revitalization Initiative 2016 Budget Initiatives to enhance Community Development
 - All La Crosse County taxpayers have a vested interest in reversing the stagnating residential tax values in the City of La Crosse. City of La Crosse residential property is declining as a share of County Property Tax Levey and the disproportional demand for services in our most challenged neighborhoods is not solely supported by the values in those areas.
 - La Crosse's residential tax base is the single largest tax base component of La Crosse County and represents more tax base than every other La Crosse County municipality (other than the total value of all property in the City of Onalaska). If the "Total Tax Base" was considered a "Stock Portfolio" we would conclude that City of La Crosse Residential Property is under-performing compared to most any other investment per capita. City of La Crosse share of

County Tax goes down each year yet Human Services and Criminal Justice demands are highest in the City of La Crosse.

- 2016 Budget Initiatives include to propose two new competitive grant programs for targeted neighborhoods, beginning with Powell-Poage-Hamilton Neighborhood.
 - Disposal Tipping Fee Grant (up to \$10,000 each). \$50,000 has been budgeted in the Solid Waste Department budget.
 - Demolition or Acquisition Grant (up to \$25,000). \$200,000 for the Neighborhood Revitalization Program.
- Property tax growth on a single property could be 167% on a \$60,000 valued house increasing to \$160,000. 14% value growth in Powell-Poage-Hamilton by revitalizing only 64 homes.

RESOLUTION NO. 41-10/15 RE: ADOPTION OF RATES FOR THE HIGH DEDUCTIBLE 2016 HEALTH PLAN AND DENTAL PLAN

WHEREAS, it is necessary to establish the premium for County health and dental insurance for those eligible non-union and union employees and continued compliance with the Affordable Health Care Act; and, WHEREAS, it is necessary to confirm TPAs for the County health and dental plans and to establish the County's portion of contribution to health and dental rates for those eligible non-union and union employees, and to fund the health and dental benefit plan at appropriate levels considering the recommendations of insurance advisors; and, WHEREAS, Mayo Medical Systems Inc. (MMSI), Gundersen Health Plan and Delta Dental qualify as sole source TPA vendors pursuant to s. 4.06(7) (g) of the Code due to their ability to deliver a unique service, their technical expertise and qualifications, their ability to deliver services at a particular time, and their ability to fulfill the needs of La Crosse County as Third Party Administrators for the La Crosse County health and dental insurance plans; and, WHEREAS, the County is authorized under law, past practice and precedent and the requirements of good fiscal management to establish plan design for cost efficient health programs for county employees, and the health benefit is a major cost item in the County NOW THEREFORE BE IT RESOLVED, that effective 1/1/2016 the active budget. contributory employee High Deductible Health Plan continues with in-network coverage at a deductible of \$1,250 for single and \$2,500 for family; with a maximum out of pocket expense of \$2,250 single and \$4,500 family; and with structure for 2016 funding levels as recommended by TPA insurance actuaries and the County's insurance advisors. BE IT **FURTHER RESOLVED,** that a Health Reimbursement Account (HRA) program is established effective 1/1/2014; and should continue in 2016; and a wellness benefit is provided for employees enrolled in the County health insurance and participating in the 2015 Health Risk Appraisal, in consultation with the County's Health insurance advisors as a consideration in the 2016 rates. **BE IT FURTHER RESOLVED,** that in 2016 for those employees enrolled in health insurance, the County shall deposit \$250 for a single or \$500 for a family plan (divided into four equal guarterly deposit payments). If the employee participates in the Healics Health Appraisal (HA) (in 2015 for 2016 deposit) they shall receive a deposit of an additional \$100 to the HRA. **BE IT FURTHER RESOLVED**, that effective 1/1/2014 and continuing in 2016 the Health and Dental insurance will be offered only to those employees working 30 or more hours per week. **BE IT FURTHER RESOLVED,** that the La Crosse County Board does hereby

RESOLUTION NO. 42-10/15 RE: AUTHORIZATION FOR CASH BALANCE TRANSFERS BETWEEN LAKEVIEW CAMPUS FUNDS AT YEAR END

WHEREAS, La Crosse County entered into an Intergovernmental Cooperation Agreement with 12 other counties to create the Mississippi Valley Health Services Commission (MVHS) to fund and operate the nursing home beds serving residents with specialized physical and mental health needs at Lakeview Health Center; and, WHEREAS, the Lakeview Health Center Campus consists of multiple services, including the (MVHS) nursing home, 2 community based residential facilities (CBRF), an adult family home, a "state only" licensed nursing home, and another CBRF currently under construction as part of the campus construction project; and, WHEREAS, these entities and MVHS were developed to maximize local, state, and federal funding while also providing the means to distribute a share of administrative costs among the multiple services and revenue streams; and WHEREAS, La Crosse County has a committed Lakeview Capital fund that is reserved for capital improvements at the Lakeview campus funded by land sales from the old Lakeview farm and a Lakeview Facility Fund which accounts for the fixed assets of Lakeview Health Center; and, WHEREAS, when closing year end financials, it is best to review all of the entities cash balances which are accounted for within separate funds, in order to determine if any cash transfers need to be made to keep each of the funds in a positive cash position for audit purposes. **NOW, THEREFORE BE IT RESOLVED**, that the La Crosse County Board authorizes the County Administrator, Finance Director and Lakeview Administrator, to approve transfers between funds for the Lakeview entities, MVHS, and Lakeview Capital at year end closeout of the financial statements, and that a report is presented to the Executive Committee each year showing any transfers that were executed, effective beginning with the fiscal year ending December 31, 2015. **FISCAL NOTE:** The balance in the Lakeview Capital fund is currently \$855,041.01, and the combined fund balances of MVHS and the other Lakeview entities as of 12-31-14 was \$3,944,302.

RESOLUTION NO. 43-10/15 RE: AUTHORIZATION TO TRANSFER ECONOMIC SUPPORT RESERVE TO MISSISSIPPI VALLEY HEALTH SERVICES COMMISSION WHEREAS, La Crosse County entered into an Intergovernmental Cooperation Agreement with 12 other counties to create the Mississippi Valley Health Services Commission (MVHS) to fund and operate the nursing home beds serving residents with specialized physical and mental health needs at Lakeview Health Center; and, **WHEREAS,** Resolution 24-8/12 authorized replacement of Lakeview Health Center with small neighborhood facilities, including reducing the number of nursing home beds from 120 to 50 on the new campus, which are nursing home beds licensed under the MVHS Commission; and **WHEREAS,** Resolution 68-2/15 accepted bids for construction of the new campus including 50 nursing home beds, which is anticipated to be ready for occupancy in the fall of 2016; and **WHEREAS,** the process of reducing client census through relocation and attrition began earlier this year which will reduce revenues, while the reduction of total staffing will not fully offset the loss of

revenues during the downsizing, so that the nursing home is projected to experience a net income loss for 2015 and 2016, but is expected to become more self-sustaining in 2017 with periodic adjustments of the MVHS per diem, while absorbing debt service payments; and WHEREAS, these projected losses are due to the downsizing and also because of the inadequacy of Medicaid reimbursement for the care of low income clientele, and cannot be fully offset by an increase in the per diem charged to MVHS member counties, which aenerated \$2.44 million in 2014, with roughly 66% paid by La Crosse County Human Services for La Crosse residents; and WHEREAS, the projected losses will be will be partially reduced through shifting cash from other Lakeview entities and the Lakeview Capital fund; and WHEREAS, County staff has considered all other reserve funds and options for offsetting the anticipated losses and recommends that the balance of the remaining economic support reserve is the most logical source, since it will protect the Human Services budget from additional costs for the care of clients at Lakeview; and WHEREAS, in 1999 La Crosse County received \$1,351,325 from the State of Wisconsin of unrestricted W-2 "profit" as a result of excess State funds, which the County could have used for any purpose, which the County designated for economic support purposes; and, WHEREAS, the County has used \$776,414.70 of these funds to offset previous year economic support budgets, with a remaining balance of \$574,910.30; and, **WHEREAS**, the economic support programs became regionalized in 2012, and the County no longer administers the W-2 program or the Food Share Employment Training program, which was the original program source of the funding. NOW, THEREFORE BE IT RESOLVED, that the La Crosse County Board authorizes the transfer of \$574,910.30 to the MVHS Commission and the Finance Director is authorized to take the actions necessary to effectuate the purposes of this resolution. **FISCAL NOTE:** The balance in Account 900-33302 Fund Balance Reserve is \$574,910.30.

Section 1. Section 11.45(2) entitled "Definition" is amended to read:

11.45 LA CROSSE COUNTY SMOKE FREE AIR ACT.

(2) DEFINITIONS. For application to County-owned, leased or rented property as provided in subsection (3), the following definition shall apply. For all other property included by adoption of Wis. Stat. §101.123, the statutory definition of smoking contained in Wis. Stat. §101.123(1)(h), or any amendments thereto, shall apply.

(a) "Smoking" shall mean inhaling, exhaling, burning or carrying any lighted or heated cigar, cigarette, pipe or any other lighted or heated tobacco or plant product intended for inhalation, including hookahs and marijuana, whether natural or synthetic, in any manner or in any form. "Smoking" shall include the use of an electronic delivery device which creates an aerosol or vapor, in any manner or in any form, or the use of any oral smoking device for the purpose of circumventing the prohibition of smoking.

(b) "Electronic Delivery Device" shall mean any product containing or delivering nicotine or any other substance intended for human consumption that may be used by a person to simulate smoking through inhalation of vapor or aerosol from the product. "Electronic Delivery Device" shall include any such device, whether manufactured, distributed, marketed, or sold as an e-cigarette, e-cigar, e-pipe, e-hookah, or vape pen, or under any other product name or descriptor.

Section 2. This Ordinance shall take effect after passage and publication as required by law.

ORDINANCE NO. 146-10/15 TO CREATE S.3.04(4) OF CHAPTER 3 ENTITLED "PROHIBITION OF SMOKING AND THE USE OF SMOKELESS TOBACCO BY EMPLOYEES" OF THE GENERAL CODE OF LA CROSSE COUNTY, WISCONSIN

The County Board of Supervisors of the County of La Crosse does ordain as follows: Section 3.04(4) is created to read: Section 1.

STANDARDS OF CONDUCT. 3.04

PROHIBITION OF SMOKING AND THE USE OF SMOKELESS TOBACCO BY (4) EMPLOYEES.

County employees are prohibited from smoking and the use of (a) smokeless tobacco in personal vehicles while transporting persons on County business and in all County buildings, vehicles, park shelters, and within 20 feet of County building doorways. (b)

The following definitions apply to this prohibition:

"Smoking" shall mean inhaling, exhaling, burning or 1. carrying any lighted or heated cigar, cigarette, pipe or any other lighted or heated tobacco or plant product intended for inhalation, including hookahs and marijuana, whether natural or synthetic, in any manner or in any form. "Smoking" shall include the use of an electronic delivery device which creates an aerosol or vapor, in any manner or in any form, or the use of any oral smoking device for the purpose of circumventing the prohibition of smoking.

"Electronic Delivery Device" shall mean any product 2. containing or delivering nicotine or any other substance intended for human consumption that may be used by a person to simulate smoking through inhalation of vapor or aerosol from the product. "Electronic Delivery Device" shall include any such device, whether manufactured, distributed, marketed, or sold as an e-cigarette, e-cigar, e-pipe, e-hookah, or vape pen, or under any other product name or descriptor.

Section 2. This Ordinance shall take effect the day after passage and publication as required by law.
