RE: AUTHORIZING ACCEPTANCE OF ADDITIONAL FUNDING FROM THE US DEPARTMENT OF AGRICULTURE TO EXPAND THE COULEE REGION FARM2SCHOOL CHILI PROGRAM

WHEREAS, the Health Department was notified of a grant award from the US. Department of Agriculture for \$100,000 to work with State Partners to expand the Coulee Region Farm2School Chili to a state-wide Farm2School menu item; and,

WHEREAS, a current .7 FTE health educator working with Farm2School has the capacity to increase their hours to a .84 FTE to cover the work needed on this grant; and,

WHEREAS, the timeline and completion of the grant requirements would benefit from this staff increase;

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board of Supervisors authorizes the increase of a .14 FTE health educator position for this grant through the end of 2019; and

BE IT FURTHER RESOLVED, that the Finance Department is authorized to make any necessary and appropriate account transfers relating to accepting this additional federal funding.

FISCAL NOTE: The cost of the increased 0.14 FTE health educator position for 2019 will be approximately \$9,038 and will be offset by the additional funding. This will be accounted for in Org 200.300.3758 USDA Chili Grant.
