RE: QUIT CLAIM DEED OF PROPERTY TO STATE OF WISCONSIN - DEPARTMENT OF TRANSPORTATION

**WHEREAS,** the County currently owns property located in two parcels along the intersection of STH 14/61/35 which was previously needed for highway right of way; and,

WHEREAS, this property is approximately 20 acres more particularly located at:

Parcel 1: Sec. 27, T15N, R7W, NW  $\frac{1}{4}$  - NE  $\frac{1}{4}$  and the NE  $\frac{1}{4}$  - NW  $\frac{1}{4}$ , recorded at Volume 228, Page 76, Document #523865

Parcel 2: Sec. 27, T15N, R7W, NW  $\frac{1}{4}$  - NE  $\frac{1}{4}$  and the NE  $\frac{1}{4}$  -NW  $\frac{1}{4}$ , recorded at Volume 161, Page 267, Document #281088; and

**WHEREAS,** the State of Wisconsin Department of Transportation has indicated that this property is now needed by the State in order to complete a highway construction project located in this area; and

**WHEREAS,** pursuant to s. 84.09, Wis. Stats., and Order of the Department of Transportation, the State has requested that this land be conveyed to the State of Wisconsin;

**NOW THEREFORE BE IT RESOLVED,** that the La Crosse County Board hereby authorizes the transfer of property as identified above to State of Wisconsin-Department of Transportation;

**BE IT FURTHER RESOLVED,** that the County Board Chair and County Clerk are hereby authorized to execute a Quit Claim Deed to transfer said property to the State of Wisconsin-Department of Transportation, after approval by Corporation Counsel.

**FISCAL NOTE:** There are no outstanding taxes regarding the parcel. No further costs to La Crosse County.
