**RE: ELECTED OFFICIALS' SALARIES FOR NEXT TERM 2021-2024, COUNTY CLERK, COUNTY TREASURER, REGISTER OF DEEDS**

**WHEREAS**, the County Board has reviewed and considered modifications of the salary for elected officials pursuant to Wisconsin State Statutes 59.22(1)(a), and;

**WHEREAS**, salaries for the Sheriff and Clerk of Courts were increased 2% for the first two years and 3% for the second two years of their term of office.

**NOW THEREFORE BE IT RESOLVED**, that the following elected officials shall be paid at the annual rates set forth on the following schedule for the 2021-2024 term commencing January 4, 2021, and for the subsequent years of the term, shall be effective January 1 for 2022, 2023 and 2024.

**BE IT FURTHER RESOLVED**, that, in addition to the above compensation, the elected officials shall also pay, as required by state law, 50% of the elected officials Wisconsin Retirement System contribution, and such changes from year to year as set by the state and WRS, and;

**BE IT FURTHER RESOLVED**, that the elected officials shall be eligible for voluntary health, dental and life insurance subject to the same terms and conditions as full-time non-represented La Crosse County employees.

**FISCAL NOTE:** The estimated cost of salary for 2021 is \$4,860 and rollups \$700. All elected officials are contributing 6.75% to the WRS for 2020.
