## RE: APPROVAL OF TOWN OF CAMPBELL ORDINANCE AMENDMENT

**WHEREAS,** the Town of Campbell has adopted a zoning ordinance, which ordinance was approved by the La Crosse County Board by Resolution #52-1/13 on January 17, 2013; and,

**WHEREAS,** Wis. Stat. s. 60.62(3) states that no zoning ordinance or amendment to a zoning ordinance may be adopted by the town unless approved by the county board; and,

WHEREAS, after a public hearing on March 10, 2020, the Town of Campbell approved an Ordinance to amend Sections 40-94 (c) (5) & 40-95 (d) (5) of the Town of Campbell Code of Ordinances related to minimum lot size and minimum lot width requirements in the Residential "B" and Residential "C" Districts; and,

WHEREAS, the Planning, Resources and Development Committee, after receiving input from Zoning, Planning and Land Information Department staff, recommend approval of the proposed zoning amendment.

**NOW THEREFORE BE IT RESOLVED,** that the La Crosse County Board hereby approves the Ordinance to amend Sections 40-94 (c) (5) & 40-95 (d) (5) of the Town of Campbell Code of Ordinances related to minimum lot size and minimum lot width requirements in the Residential "B" and Residential "C" Districts approved by the Town of Campbell on March 10, 2020 in accordance with Wis. Stat. s. 60.62(3).
