HONORABLE MEMBERS OF THE LA CROSSE COUNTY BOARD OF SUPERVISORS

AUTHORIZING ACCEPTANCE OF COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING FROM THE CITY OF LA CROSSE TO SUPPORT THE HINTGEN / HUBER PROJECT OF THE LA CROSSE AREA FAMILY COLLABORATIVE

**WHEREAS,** The City of La Crosse, Wisconsin, has awarded Community Development Block Grant (CDBG) funding in the amount of \$50,000 to La Crosse County Human Services to help support the Hintgen / Huber Project of the La Crosse Area Family Collaborative (LAFC); and,

**WHEREAS,** the LAFC is an asset to the Huber neighborhood in the City of La Crosse by making available a neighborhood social worker and flexible funding to stabilize low and moderate income families before their situations require a crisis response from the child welfare and other emergency systems; and,

**WHEREAS,** The CDBG funds will be allocated over a period of two (2) years effective April 1, 2021, through March 31, 2023, at \$25,000 per year and will be utilized to offset program costs.

**NOW THEREFORE BE IT RESOLVED,** that the La Crosse County Board hereby accepts the CDBG award in the amount of \$50,000 and authorizes the County Administrator to execute any documents to effectuate this resolution, after approval by Corporation Counsel; and,

**BE IT FURTHER RESOLVED,** that the Finance Department is authorized to make any necessary and appropriate account transfers related to accepting this additional funding.

**FISCAL NOTE:** Total grant award is \$50,000 over two years, with no County match required, and the award period ending March 31, 2023. The operating costs will be tracked under the 210.500.4242 division within the County financial system under the Justice Support Services section.
