ANALYSIS

Section 19.07 of the County Code requires dogs (and cats) to be leashed in County Parks. The development of a dog park at Veteran's Memorial Park would require a change to the ordinance. This amendment provides an exception which allows dogs to be off leash in the fenced-in area designated as the dog park at Veteran's Memorial Park.

INFORMATION:

County Board Rules: Governing Body s. 2.02(8) states, in part: Ordinances are drafted by the Corporation Counsel. After the ordinance has been reviewed by a standing committee, each Supervisor will be given a copy of the ordinance showing the deleted language (grayed) and the new language (underlined) and an analysis of the intent of the ordinance. After introduction to the County Board, the ordinance shall be referred to the next monthly meeting unless waived by a 2/3 vote of the Supervisors present and a public hearing may be held if requested by a Supervisor. An amendment may be introduced and debated at either the original or the referred meeting. ORDINANCE <u>#186 - 4/21</u>

AN ORDINANCE TO AMEND SECTION 19.07 OF CHAPTER 19 ENTITLED "PARKS" OF THE GENERAL CODE OF LA CROSSE COUNTY, WISCONSIN

The County Board of Supervisors of the County of La Crosse does hereby ordain as follows:

Section 1. Section 19.07 is amended to read:

19.07 DOGS AND CATS RESTRICTED. No person having charge or control of any dog or cat shall allow such dog or cat to run at large within a County park, but shall keep such dog or cat under control on a leash at all times.

- (a) EXCEPTION. Dogs are permitted to be off-leash within the confines of the fenced area designated as the dog park located at Veteran's Memorial Park.
- **Section 2.** This Ordinance shall take effect after passage and publication as required by law.
