COMMUNICATIONS AND ANNOUNCEMENTS: County Board Chair Report - Monica Kruse

- Mask Advisories and Vaccine Mandates
 - The US DOJ has ruled that mandatory vaccines in the workplace are allowed. If a person refuses to be vaccinated, they can be terminated. Currently, La Crosse residents with at least one dose of vaccination is at 58.3%. La Crosse County is not mandating vaccinations at this point. Wanda Plachecki, Director of Long-Term Care at Hillview and Lakeview reported that they are working on vaccinations of their staff and residents and are at a good compliance. All staff

were required to get education and information on the vaccines, and they achieved an 86% staff compliance at Lakeview and 81% compliance at Hillview for vaccinations. Unvaccinated staff are required to get additional training and education on vaccinations quarterly and again declare not getting vaccinated. Nursing homes are still being tested on a regular basis based on the County's positivity rate and wearing masks and PPE based on the County's transmission rate. Human Resources Director Stephen Conrad updated on the County policy on flu and covid which suggests vaccinations but does not require it. This policy can be changed down the road if the vaccinations become required. The County is following the CDC guidelines and currently requiring masks.

RESOLUTION NO. 14-8/21 RE: DISASTER DECLARATION RELATED TO FLOODING EVENTS OF AUGUST 2021

WHEREAS, on August 7, 2021 a disaster, namely torrential rain and flooding, struck La Crosse Wisconsin; and WHEREAS, these conditions continued after August 7 and, pursuant to National Weather Service Advisories, are predicted to continue through August 12, 2021 at 1:00 a.m.; and WHEREAS, the disaster has caused and continues to cause the County to expend, commit and exhaust its pertinent available resources; and WHEREAS, pursuant to Wis. Stat. §323.11, the County Board has the power to declare a condition of disaster when it is necessary and expedient for the health, safety, welfare and good order of the county to proclaim that emergency conditions exist; and WHEREAS, the declaration of an emergency pursuant to State Statute Ch. 323, Emergency Management, and the La Crosse County Code, will allow the potential authorization of the following activities during the period of emergency conditions: Evacuation and traffic re-routing as needed; purchase or rental of needed equipment; requesting assistance of Wisconsin National Guard as needed for flood protection & mitigation; requesting state resources as needed including WEM Regional Director, DNR, State Patrol; suspending special exception permits as needed; establishing price controls for debris management; authorizing the emergency purchases of goods and material; authorizing the emergency hiring of EM/EOC, LTE or others as needed; authorizing public works contracting in excess of \$20,000 without advertising or bid for the Highway Department and Facilities/Parks: and WHEREAS, the county requests state assistance and advises the State of Wisconsin of our emergency conditions; NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board of Supervisors hereby declare a condition of disaster and further declare that the period of emergency shall be limited to the time during which the emergency conditions exist or are likely to exist.

Motion by V. Burke/P. Viner to approve. Discussion ensued. Highway Commissioner Joe Langeberg reviewed the roadways where damage occurred from the storms and potential repair costs. The motion to approve passed on a unanimous voice vote with 25 ayes, 4 excused - K. Cable, A. Richmond, T. Tryggestad and N. Weber Strauss.

- La Crosse County Sustainability Indicators 2020 Report presented by Anders Olson.
 - o La Crosse Sustainability Indicators look at the government operations of electricity usage, natural gas usage, vehicle fuel usage, CO2 emissions and paper usage. It also looks at Community-Wide waste and recycling, transportation, land use, and socio-economic conditions. The annual electricity usage has gone down 24% since 2007, natural gas usage is down 41%, vehicle fuel usage is down 5%, total CO2 emissions are down 48% and annual paper usage was down 67%. Cumulative savings from 2008 2020 has been \$975,000 electricity, \$484,000 natural gas, \$145,000 vehicle fuels and \$1,146,000 paper for a total of \$2.75 million in savings. County Government has achieved significant progress in resource conservation since 2007 with smaller energy consumption and reduced paper consumption. Conservation has yielded significant benefits with energy cost savings and reduced carbon footprint.
- Xcel Energy Annual 2020 French Island Report presented by Mike Hero, Tina Ball, Jared Graham, Brey Mauer, and Todd Baus.

- A video was shown to describe and show the operations at the French Island Plant. Tours will be available in the future. A full report was distributed to Supervisors.
- 2020 Annual Financial Report
 - o Finance Director Sharon Davidson noted three reports are done each year; Annual Comprehensive Financial Report (ACFR), Popular Annual Financial Report (PAFR), and the Single Audit. The ACFR includes the introduction. financial section which contains the management's decision and analysis and financial statements, and the statistical section which contains the principal property taxpayers and principal employers. The Finance Department has received the Certificate of Achievement for Excellence in Financial Reporting for 15 consecutive years and the Award for Outstanding Achievement in Popular Annual Financial Reporting for 6 consecutive years. The Single Audit showed 2020 Federal Grant expenditures at \$25,750,007 and 2020 State Grant expenditures at \$12,015,950. The three types of funds are the Governmental Funds, Enterprise Funds, and Internal Service Funds. Governmental Funds are used to account for activities funded primarily through property taxes and intergovernmental revenues, Enterprise Funds are used to account for activities funded primarily by fees charged to external parties, and Internal Service Funds are used to account for goods or services provided by one department to other departments or governmental units.
- Presentation on 2020 Annual Audit by Baker Tilly presented by Andrea Jansen
 - o The financial audit of the County's financial statements for 2020 were done in accordance with auditing standards generally accepted in the United States and standards applicable to financial audits contained in Government Auditing Standards and issued an unmodified opinion. The Single Audit completed the testing and reported a low-risk auditee with no findings. No material weaknesses or significant deficiencies were identified during the audit.
