RE: AUTHORIZATION TO USE AMERICAN RESCUE PLAN ACT (ARPA) FUNDS FOR COVID RELATED EXPENDITURES IN 2021

WHEREAS, The La Crosse County Board approved the 2022 budget on November 8th, 2021; and,

WHEREAS, this budget included approved housekeeping changes to include a placeholder of \$22,923,224 for ARPA expenditures in a new fund; and,

WHEREAS, these funds cannot be spent without County Board approval; and,

WHEREAS, COVID-19 transmission rates remain high and continue to impact the community; and,

WHEREAS, County Departments are incurring the following types of unbudgeted and unfunded expenditures during the continued COVID-19 pandemic:

- Staffing for disease investigation, contact tracing, testing, and support to community partners,
- · Equipment to onboard and support higher staffing levels in the Health Department,
- Isolation of at-risk unsheltered individuals in the community,
- Masks, plastic barriers, and other protective equipment; and,

WHEREAS, these unfunded expenditures are allowable uses for ARPA funds; and,

WHEREAS, allowable COVID-19 expenditures are not anticipated to exceed \$705,950 through December 31, 2021.

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby authorizes a maximum of \$705,950 of the total expected \$22,923,224 allocation to be spent on allowable expenditures related to the COVID-19 pandemic.

BE IT FURTHER RESOLVED, the Finance Department is authorized to make any necessary and appropriate account transfers.
