WHEREAS, undertaking hazard mitigation actions before disasters occur will reduce the potential for harm to people and property and save taxpayer dollars; and

WHEREAS, an adopted all hazards mitigation plan is required as a condition of future grant funding for mitigation projects; and

WHEREAS, La Crosse County participated jointly in the planning process with the other local units of government within the County to prepare a Multi-Hazards Mitigation Plan; and

NOW, THEREFORE, BE IT RESOLVED, that La Crosse County, hereby adopts the La Crosse County Multi-Hazards Mitigation Plan 2020-2024 as an official plan; and

BE IT FURTHER RESOLVED, that the La Crosse County Emergency Management Department will submit on behalf of the participating municipalities the adopted La Crosse County Multi-Hazards Mitigation Plan 2020-2024 to Wisconsin Emergency Management and Federal Emergency Management Agency officials.

FISCAL NOTE: There is no cost to La Crosse County. Adoption of the plan will make La Crosse County eligible to apply for federal and state grants to assist in the recovery from future events.
