Stats. NOW THEREFORE BE IT RESOLVED, that La Crosse County shall apply for funds under s. 23.09(26) Wis. Stats. for such eligible maintenance, acquisition, insurance, rehabilitation and/or development costs; BE IT FURTHER RESOLVED, that the La Crosse County Board does authorize the County Board Chair or her designee in the La Crosse County Facilities Department to act on behalf of La Crosse County to submit an application to the State of Wisconsin, Department of Natural Resources for any financial aid that may be available; sign documents; and take necessary action to undertake, direct and complete the approved project. WHEREAS, the Board has approved of the formation of the Comprehensive Plan Advisory Committee (CPAC) to guide the work of updating the County's Comprehensive Plan in accordance with Wis. Stats. s. 66.1001; and, WHEREAS, Wis. Stats. s. 66.1001(4)(a) requires that the County adopt written procedures that are designed to foster public participation, including open discussion, communication programs, information services, and public meetings for which advance notice has been provided, in every stage of the preparation of a comprehensive plan; and WHEREAS, the current COVID-19 pandemic will make it necessary to use a wide variety of tools to effectively engage the public, communicate the recommendations of the CPAC, and gather broad public feedback throughout the Comprehensive Plan Process; and WHEREAS, County staff has researched a variety of online platforms to assist with public engagement through the comprehensive plan process, and has determined that Cityzen Solutions Inc. DBA PublicInput.com would be the best option to provide engagement tools such as surveys, polls, map comments, public meetings, telephone hotlines, etc, as well as analysis of the input that is received. NOW THEREFORE BE IT **RESOLVED** that the County Board approves of contracting with Cityzen Solutions Inc. DBA PublicInput.com for an agency license to use the publicinput.com platform for public engagement for a one-year term; and, BE IT FURTHER RESOLVED, that the Board Chair is hereby authorized to sign all necessary documents with Cityzen Solutions Inc. DBA PublicInput.com, after approval by Corporation Counsel. FISCAL NOTE: The first-year license fee will be \$20,403, which will be paid from account 100.180.1000-66540.03 Special Projects Comp Plan within the Zoning Org, with funding coming from the General Fund Unassigned Fund Balance, account 100-34501.001.

# RESOLUTION NO. 58-3/21 RE: AUTHORIZING PURCHASES RELATED TO RUNAWAY AND HOMELESS YOUTH SERVICES

WHEREAS, La Crosse County Youth Justice was presented with a unique opportunity from the Wisconsin Department of Children and Families (DCF) to provide financial support for Runaway and Homeless Youth Services (RHYS) within La Crosse County as the current provider, from the Chippewa/Eau Claire County area, was no longer able to fulfill DCF's contract; and, WHEREAS, La Crosse County was awarded \$69,000 to support these runaway and homeless youth services through the current State contract period which runs from January 1, 2021 through December 31, 2021, with the opportunity for local collaborative service providers to apply directly for future funding to support and sustain these services beyond this timeframe; and, WHEREAS, La Crosse County Youth Justice and its youth serving partners report a significant need for service in this area, as evidenced by partner statistics highlighted in a recent Request for Proposal stating, "During the 2018-2019 school year, 227 La Crosse County students were reported to experience homelessness by school district personnel"; and, WHEREAS, as a result of a recent Request for Proposal process, La Crosse County Youth Justice will use the RHYS award to contract with Black Leaders Acquiring Collective Knowledge (B.L.A.C.K.) in partnership with a number of youth serving agencies, including, but not limited to: The Center: 7 Rivers LGBTQ Connection, Cia Siab, Inc., The Good Fight Community Center, YWCA La Crosse, and Family and Children's Center Host Home Programs. NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby accepts the 2021 Runaway and Homeless Youth Services award in the amount of \$69,000. and the County Administrator is authorized to execute any documents to effectuate this Resolution after approval of Corporation Counsel; and, **BE IT FURTHER RESOLVED**, that La

Crosse County is authorized to contract for all other services that are necessary to meet the terms of the Runaway and Homeless Youth Services contract as long as they can be supported with the related state funding; and, **BE IT FURTHER RESOLVED**, that the Finance Department is authorized to make any necessary and appropriate account transfers related to accepting this additional funding. **FISCAL NOTE:** Award funds of a total \$69,000, with no County match required, and the award period ending December 31, 2021. The operating costs will be tracked under the 210.510.5235 division within the County financial system under the Justice Support Services section.

## RESOLUTION NO. 59-3/21 RE: SUPPORT FOR AMENDMENTS TO 2019 WISCONSIN ACT 106 AND WIS. STATS. 343.31(1M)(B) REGARDING OPERATING WHILE INTOXICATED (OWI) OFFENSES

WHEREAS, 2019 WISCONSIN ACT 106 was enacted on February 28, 2020 to amend 346.65(2)(am)5 of the statutes, relating to commission of a fifth or sixth offense of operating a motor vehicle while intoxicated; and, WHEREAS, §346.65(2)(am)5 reads as follows: "The court shall impose a bifurcated sentence under s. 973.01, and confinement portion of the bifurcated sentence imposed on the person shall be not less than one year and 6 months. The court may impose a term of confinement that is less than one year and 6 months if the court finds that the best interests of the community will be served and the public will not be harmed and if the court places its reasons on the record."; and, WHEREAS, pursuant to s. 973.01(2), "A bifurcated sentence is a sentence that consists of a term of confinement in prison followed by a term of extended supervision under s. 302.113." and pursuant to s. 973.01(2)(b), "The portion of a bifurcated sentence that imposes a term of confinement in prison may not be less than one year..."; and, WHEREAS, in October 2020, the Wisconsin Department of Justice (WI DOJ) issued an opinion stating that, for an offense under Act 106, the court must impose a bifurcated sentence with at least 1 year of initial confinement; and, WHEREAS, the WI DOJ further opined that, by requiring that a court 'shall impose a bifurcated sentence' with a confinement portion that is spelled out in the statutes, the Legislature created a mandatory minimum sentence that a court must impose and that, under the decisions in State v. Lalicata and *State v. Williams*, a court may not impose and stay that sentence and order probation; and, WHEREAS, under the law as amended, 5<sup>th</sup> and 6<sup>th</sup> Offense OWI offenders would have no incentive to participate in a Treatment Court program, which would address both underlying criminogenic and substance abuse needs, because prison is required; and, WHEREAS, treatment courts have been restoring lives and families for more than three decades and have been shown to be one of the most successful justice system interventions in our nation's history, and significantly improve substance use disorder treatment outcomes, substantially reduce addiction and related crime, and do so at less expense than any other criminal justice strategy; and, WHEREAS, the Wisconsin Legislature has recognized the importance and positive impact of treatment courts in Wisconsin and has significantly supported treatment courts through legislation such as Treatment Alternatives and Diversion (TAD); and, WHEREAS, La Crosse County advocates for changes to 2019 WISCONSIN ACT 106 to allow for participation in treatment courts for a 5<sup>th</sup> or 6<sup>th</sup> OWI offense; and, WHEREAS, additionally, under §343.31(1m)(b) if the number of convictions for OWI equals 4 or more and the 4<sup>th</sup> conviction occurs within 15 years of the previous conviction, the Department of Transportation shall revoke the person's operating privilege permanently; and, WHEREAS, individuals who successfully complete a treatment court program which addresses their underlying criminogenic and behavioral health needs, under court supervision, should have the opportunity to reinstate their driver's license. Such incentive would encourage other individuals to participate in treatment courts to obtain these services, which ultimately, improves public safety. NOW THEREFORE BE IT RESOLVED that La Crosse County Board of Supervisors does hereby implore the Wisconsin legislature to amend ACT 106 to allow, at sentencing for 5<sup>th</sup> and 6<sup>th</sup> offense OWI convictions, the option to impose and stay a sentence

and to place the defendant on probation in order to participate in and complete a treatment court program. **BE IT FURTHER RESOLVED** that the La Crosse County Board of Supervisors does hereby further implore the Wisconsin legislature to amend Wis. Stats. §343.31(1m)(b) to allow for reinstatement of an individual's operating privileges upon successful completion of a treatment court. **BE IT FURTHER RESOLVED** that the County Clerk be authorized and directed to send a copy of this resolution to Governor Evers, Attorney General Kaul, State Courts Director Randy Koschnick, members of the State Assembly, members of the Wisconsin State Senate, and the Wisconsin Counties Association. **FISCAL NOTE:** Amendments to ACT 106 are anticipated to result in overall cost savings to various public systems through improving substance abuse disorder treatment outcomes. There is no direct spending of funds authorized in this resolution. Treatment court program costs will continue to be funded by La Crosse County Human Services Department.

- 2. All wastewater generated on-site must be collected or treated and dispersed in accordance with rules administered by the La Crosse County Environmental Health Department. No surface discharge of grey or black wastewater is allowed;
- **3.** A 911/address number is required if one has not already been assigned. Contact the Zoning Department to fulfill this requirement;
- **4.** This permit authorizes a maximum occupancy of the recreational vehicle of 60 days per year and does not allow use of this RV as a principal residence;
- 5. The RV and related items are not to be located within the floodplain district;
- **6.** Decks, sheds, attachments or other structures may require the issuance of a Zoning/Occupancy Permit. Contact the Zoning Department prior to construction;
- **7.** Any improvements to the access road within the floodplain require permitting through La Crosse County Zoning;
- 8. This permit is non-transferable;
- **9.** This permit will terminate automatically after discontinuance of the use of this site for 12 consecutive months and termination does not require a hearing before the PR&D Committee; and
- **10.** Any additional conditions approved by the Town Board are to be made conditions of this Conditional Use Permit.
