## PROCLAMATION AUGUST 2022 - CHILD SUPPORT AWARENESS MONTH

WHEREAS, La Crosse County recognizes children as our greatest resource; and, WHEREAS, children living in La Crosse County should always have the financial and emotional support they need in order to be successful; and, WHEREAS, Wisconsin's Child Support Program ensures that parents take responsibility for the care and well-being of their children, supports the involvement of parents in their children's lives, and provides important services to both custodial and noncustodial parents; and, WHEREAS, the La Crosse County Child Support agency collected more than \$43 million in child support in 2021; and, WHEREAS, upholding the Child Support Program is an effective investment in Wisconsin's future as the program increases self-sufficiency, reduces child poverty, and has a positive effect on children's well-being; and, WHEREAS, increased public awareness of the importance of providing children with the support they need and the services offered by the Child Support Program, through its county and tribal-child support agencies, benefits Wisconsin's children and families. NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board does hereby proclaim the month of August as Child Support Enforcement Awareness Month and urges all residents to join in recognizing the valuable contribution of persons dedicated to ensuring children receive the financial and emotional support they need to be successful.

- 2023 Highway Capital Improvement Plan
  - O Highway Commissioner Joe Langeberg reviewed the 2022 projects that the Highway Department has finished are working on. The planned construction projects for the 2023 2027 were also reviewed and discussed. These projects are determined by pavement rating. If the funding for a project is through the WisDOT, they have the final say on when the project will be done. The projects include reconstruction, recondition, culverts, trail connection, bike trail bridge, resurfacing, or bridge reconstruction. The Capital Improvement Plan for road construction has been increased from \$5 million a year to \$7 million a year. This will come through the budget this year.
- La Crosse County Broadband
  - o Community Development Coordinator Charlotte Peters presented on Broadband in La Crosse County. Broadband became an issue during COVID. Governor Evers created a taskforce to look at the problem. The goal is to have all homes with base level speeds by 2025 and to have 1Gbps by 2030. ISP providers who come across homes with no services will be added to their list. Approximately 380 homes and 14 businesses are without service and not slated to get service. Underserved homes are designated as homes with less than 25/3 Mbps speeds. In La Crosse County, 1402 underserved homes that can access the internet have no subscription and 5301 have no internet access. In underserved areas, there are 171 houses with members under 18 years of age have no computers; 1526 of 18-64 years old have no computers and 3445 houses with no computers of age 65 and over. It's important to show the importance of having the internet. The County needs to

create a committee to prepare community readiness. There are a number of grants that are available for this.
