Tax parcel 9-1225-2. Property address W4911 Puent Rd, Town of Medary. And pursuant to s. 59.69 Wis. Stats, and s. 17.36 Zoning Code: the Committee did publish and receive proof of a Class II notice of the hearing; did receive receipts of mailing of the notices to the affected Town Clerk(s); did hold a public hearing to hear testimony or correspondence from the people; and, did receive and consider action from the affected Town Board(s). The Committee, under s. 91.48(1), Wis. Stats., along with the affected Town Board(s), under s. 17.36(4), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record, the Committee's recommendation is to: By a vote of FIVE (5) in favor (Hesse, Hundt, Keil, Hoyer, Scheller), TWO (2) no (Isola, Cornforth), and ZERO (0) abstentions, the committee recommended Approval of Conditional Use Permit No. 1180 subject to the following FOUR (4) conditions:

- A maximum of EIGHT (8) dogs can be on site at any one time. This includes the FOUR
 (4) dogs owned by the applicants.
- 2. This permit shall terminate upon certification of noncompliance with La Crosse County Ordinance Chapter 11 by the La Crosse County Health Department.
- 3. This permit is non-transferable.
- 4. Boarded dogs shall remain indoors from dusk until dawn.

ORDINANCE NO. 191-1/22 TO AMEND S. 15.02, 15.04 AND 15.05 ENTITLED "SOLID WASTE MANAGEMENT" OF THE GENERAL CODE OF LA CROSSE COUNTY, WISCONSIN

The County Board of Supervisors of the County of La Crosse does ordain as follows:

Section 1. Section 15.02 entitled "Definitions" is amended to read:

- 15.02 DEFINITIONS. For the purpose of this Code, the following words and phrases shall have the meaning given herein unless their use in the text of the Code clearly demonstrates a different meaning.
- (25) La Crosse County Landfill Complex Facilities. The solid waste and recycling facilities and operations controlled by La Crosse County which are presently located at 3200 Berlin Drive, La Crosse, Wisconsin. These facilities and operations may change from time-to-time. The facilities include: sanitary landfill; pallet, crate and clean wood processing; asphalt shingle processing; aggregate processing; the demolition area; the yard waste site; tire recycling; asbestos disposal; bioremediation of petroleum impacted soils; citizen's disposal area; closed landfill; and ash monofill.

Section 2. Section 15.04 entitled "Powers and Duties of the Solid Waste Director" is amended to read:

(5) Permits. The Director is hereby authorized to issue permits for all elements of solid waste management referred to in s. 15.05. There shall be restrictions on transferability of such permits. Permits shall be for a term of 1 year or less and shall be subject to the fees set forth in s. 5.09. All permits so issued shall be conditioned upon observance of the laws of Wisconsin, and all applicable county ordinances and regulations.

Section 3. Section 15.05 entitled "Permits for Management of Solid Waste: is amended to read:

- (3) Special Permit Provisions.
- (a) There shall be a 3 consecutive day permit available for payment of 1/12 the annual permit fee. This permit shall only be valid for use of the La Crosse County Disposal System. In this section, 3 consecutive days means 3 consecutive days when the Landfill Complex Disposal System Facilities are open for business.
- (b) The Solid Waste Director may issue 1-time disposal authorizations without a permit fee for trial loads or where unique circumstances apply.
- (c) The Solid Waste Director may issue a single trip permit for utilizing the landfill. Single trip permits are issued on a temporary basis at entry and must be returned when exiting the facility.

Section 4. This Ordinance shall take effect the day after passage and publication as required by law.

RESOLUTION NO. 53-1/22 RE: SUPPORT FOR DESIGNATION OF THE GOOSE ISLAND CONNECTOR TRAIL AS PART OF THE MISSISSIPPI RIVER TRAIL WITHIN LA CROSSE COUNTY

WHEREAS, bicycle tourism is a growing industry in North America, contributing \$47 billion a year to the economies of communities that provide facilities for such tourists; and WHEREAS, the Mississippi River Trail is a national bicycle route, along the length of the Mississippi River, through ten states, from the headwaters at Lake Itasca to the Gulf of Mexico; and WHEREAS, the Mississippi River Trail was designated as one of only 16 National Millennium Trails which honor the past and imagine the future by preserving and commemorating major events and aspects of America's history and culture; and WHEREAS, the Goose Island Connector Trail will enhance the Mississippi River Trail to provide access to and promote the scenic, historic, archaeological, cultural, recreational and natural qualities of the Mississippi River and its

amenities; and WHEREAS, the Mississippi River Trail is located primarily on the Wisconsin All-American Great River Road National Scenic Byway (WIS 35) between Prescott and Illinois State Line, but also routed on other state and county highways, local roads or alternative routes for bicycling; and WHEREAS, the Wisconsin Mississippi River Parkway Commission and La Crosse County with the cooperation of the Wisconsin Department of Transportation, Wisconsin Department of Natural Resources and other stakeholders, have proposed a specific route to be designated as Goose Island Connector trail as part of the Mississippi River Trail: and WHEREAS, the Mississippi River Trail implements Wisconsin Statutes Chapters 1.11, 84.01(35), 84.60, and 85.02, 349.23and Wisconsin Administrative Code Chapter Trans 400 which required that "due consideration to establishing bikeways and pedestrian ways in all new highway construction and reconstruction projects"; and WHEREAS, the Goose Island Connector Trail adds value to existing roads and trails; and WHEREAS, the Goose Island Connector Trail is largely ready to sign and market, and many suggested improvements are already planned; and WHEREAS, the Goose Island Connector Trail as part of the Mississippi River Trail will contribute to sustainable economic development in 33 Wisconsin Mississippi River communities; and WHEREAS, the proposed route for the Goose Island Connector Trail comes through La Crosse County and can therefore provide a benefit to our residents and businesses; and WHEREAS, the Goose Island Connector Trail will provide increased recreational and transportation choices for individuals to enjoy the outdoors as well as provide health, economic, and quality of life benefits; and WHEREAS, the Mississippi River Trail continues Wisconsin's tradition of honoring and enhancing the Mississippi River by offering multiple bicycling experiences, each in a unique river landscape. NOW THEREFORE, BE IT RESOLVED, that the La Crosse County Board hereby supports the development of the Goose Island Connector Trail as designated to run along the west of State Highway 35 from the southern border of the La Crosse City limits to CTH GI within the town of Shelby and La Crosse County. BE IT FURTHER RESOLVED, County staff have investigated the proposed route and find it to be a suitable route, and desire that the route be designated so that it can be mapped and signed, thereby promoting bicycle tourism in our area and that the La Crosse County Highway Commissioner shall serve as the primary point of contact on behalf of the County, FISCAL NOTE: Designation of the Goose Island Connector trail will facilitate application for grant funding that may require a local match. The shared local funding will be negotiated between the Town of Shelby, City of La Crosse and La Crosse County that will be considered in future annual budgets. The exact amount of local funding is not known at this time and this resolution does not obligate the County to a specific funding allocation.

RESOLUTION NO. 54-1/22 RE: QUIT CLAIM DEED OF PROPERTY TO STATE OF WISCONSIN – DEPARTMENT OF TRANSPORTATION

WHEREAS, the County currently owns property located along STH 35 in the Town of Onalaska, which was previously needed for highway right of way; and, WHEREAS, the State of Wisconsin Department of Transportation is in the process of disposing of surplus right of way located along STH 35. This disposal process will require that title to the right of way, initially purchased by La Crosse County in trust for the State be transferred to WisDOT; and WHEREAS, this property is approximately .9 acres more or less particularly located at:

A parcel of land in T17N, R7W, Sec. 32, in the SE1/4-NW1/4 thereof, consisting of that portion of that certain tract of land described in the Office of the Register of Deeds for La Crosse County in Volume 188 of Deeds on page 229 lying northeast of a line located 70 feet southwest of, measured normal to the following described centerline:

FISCAL NOTE: There are no outstanding taxes regarding the parcel. No further costs to La Crosse County.

RESOLUTION NO. 55-1/22 RE: APPROVING THE RESERVATION OF AMERICAN RESCUE PLAN ACT (ARPA) FUNDS FOR EIGHT PROJECT AREAS, DIRECTING COUNTY STAFF TO CREATE IMPLEMENTATION TEAMS TO COMPLETE DETAILED PLANS FOR EACH PROJECT TOWARD FUTURE CONSIDERATION BY THE COUNTY BOARD WHEREAS, President Biden signed the American Rescue Plan Act of 2021, a \$1.9 trillion emergency legislative package to provide the resources needed to address the ongoing COVID-19 public health crisis and spur a strong economic recovery, into law on March 11, 2021; and, WHEREAS, components of the act included \$242 billion in economic impact payments to individuals and families, an increase and expansion of the Child Tax Credit, \$10 billion for states, territories and Tribes to cover the cost of capital projects, \$21.6 billion for states, territories and local governments to assist households that are unable to pay rent and utilities due to the COVID-19 crisis, \$10 billion to state and Tribal governments to fund small business credit expansion initiatives, and \$350 billion in emergency funding for state, local, territorial, and Tribal governments to remedy the mismatch between rising costs and falling revenues; and, WHEREAS, La Crosse County was allocated \$22,923,224, with \$11,461,612 received in June 2021 and the second allotment to be received in 2022; and, WHEREAS, the La Crosse County Board has authorized \$705,950 for COVID related expenditures in 2021 as described in Resolution #44-12-21, leaving a total of \$22,217,274 for future disbursement; and WHEREAS, the funding must be obligated by the end of 2024 and spent by the end of 2026; and, WHEREAS, based on guiding values of guality of life, equity and collaboration, recommendations from a community survey with over 1,500 responses and seven task forces with more than 80 community members providing input, the La Crosse County Board of Supervisors prioritized projects on December 6, 2021 that fall under ARPA's eligible categories. NOW THEREFORE BE IT RESOLVED, that La Crosse County's ARPA funding will be reserved for the following projects and as described on the attached narrative document:

- 1. \$3,300,000 New or expanded high-quality childcare: Childcare Neighborhood Model
- 2. \$3,000,000 Affordable housing development: Bridge Housing for Families
- 3. \$2,425,000 Economic impacts: Skilled Trades Training
- 4. \$3,000,000 Affordable housing development: Bridge Housing for Adults with High Needs
- 5. \$2,000,000 Affordable housing development: Grants for Housing Redevelopment
- 6. \$5,000,000 Maintenance or building of infrastructure: Hillview Redesign and Rebuild
- 7. \$1,500,000 Sustainability: Green Infrastructure County Solar
- 8. \$2,000,000 Sustainability: Stormwater Infrastructure Grant Fund

For a total of \$22,217,274 remaining La Crosse County ARPA allocation.

BE IT FURTHER RESOLVED, that County staff is directed to create implementation teams to ensure that projects move forward and other funding sources are pursued; and, BE IT FURTHER RESOLVED, that the expenditure of any of the reserved ARPA funds will require County Board approval by resolution; and BE IT FURTHER RESOLVED, that implementation teams will report back to the County Board on progress on a quarterly basis, and that the County Board may consider potential reallocations of funding at that time based on new information or opportunities that could impact a particular project. FISCAL NOTE: La Crosse County's received \$11,461,612 in 2021 and anticipates receiving the same amount in 2022, while a total of \$705,950 has been authorized for COVID related expenditures in 2021. The balance of \$22,217,274 is included in the 2022 budget. Any funds not expended in 2022 will be carried forward to future annual Budgets as considered by the County Board.
