RE: AUTHORIZING ADDITION OF 2.0 FTE ADMINISTRATIVE SPECIALIST POSITIONS IN THE HEALTH DEPARTMENT

WHEREAS, the Wisconsin Department of Health Services recently updated recommendations to Local Health Departments clarifying and prioritizing the goals of communicable disease work at this point in the SARS COVID-19 pandemic; and,

WHEREAS, La Crosse County Health Department has in addition to regular employees used multiple limited term employees during a two year period of the pandemic to date to fulfill the duties needed for community support; and,

WHEREAS, the Health Department has ongoing operational needs at the current time which can be addressed with the addition of staff positions;

NOW THEREFORE BE IT RESOLVED that the La Crosse County Board hereby approves the addition of 2.0 fulltime equivalent Administrative Specialists in 2022.

BE IT FURTHER RESOLVED that the Human Resources department is authorized to take the necessary steps to fill the positions in cooperation with the Health Department as soon as practical.

FISCAL NOTE: The positions would cost approximately \$98,184 for the remainder of 2022, which includes benefits. Sufficient funds exist in the Health fund reserves to cover the staffing costs in 2022.
