WHEREAS, beginning in the 1970s, Hmong families immigrated to the United States as refugees to escape persecution and poverty in the aftermath of the Vietnam War; and, WHEREAS, on arrival in this country many Hmong immigrants were greeted with racism and hatred despite their support of the United States war effort in Vietnam; and, WHEREAS, the Hmong community in Wisconsin, including La Crosse

County, resisted attempts to marginalize their identities, language and traditions; and, **WHEREAS**, Hmong people in La Crosse County and throughout the United States continue to make remarkable economic, cultural and political contributions to our society and have made our country immeasurably stronger and richer; and, **WHEREAS**, Wisconsin has the third largest Hmong population of any state in the nation; and, **WHEREAS**, we are proud that at least 3,400 Hmong people now live in La Crosse County and today we celebrate and recognize their history, culture and vast contributions to our county, state and nation. **NOW THEREFORE BE IT RESOLVED**, that the La Crosse County Board does hereby proclaim May 14 Hmong American Day.

The La Crosse Center Board is proceeding with exploring contract management for running the La Crosse Center. Larson General received a \$10,000 innovation and diversification grant.

## Administrator Report - Steve O'Malley

## PROCLAMATION MAY 2022 - LAW ENFORCEMENT/PUBLIC SAFETY & COURTS MONTH

WHEREAS, in a free society, law enforcement is entrusted and expected to protect the civil rights of its residents and visitors to our community; and, WHEREAS, La Crosse County employees serve to enhance public safety in the Courts, District Attorney, Sheriff, Emergency Management Coordination, Medical Examiner and Public Safety Communications; and, WHEREAS, thousands of residents and visitors are helped each year by the professionals who respond to emergencies and assist those in need. NOW THEREFORE BE IT RESOLVED, the La Crosse County Board does hereby proclaim the month of May as Law Enforcement, Public Safety & Courts Month and urges all residents to join in recognizing the valuable contribution of persons dedicated to ensuring the safety of its county's residents and visitors to our community.

Motion by J. Pogreba/D. Ferries to approve passed on a unanimous voice vote with 26 ayes, 4 excused - M. Baroni, K. Cable, K. Hoyer and D. Wacek.

- Accomplishments and Comparative Data
  - Administrator O'Malley gave a review for the 19 years her served as the La Crosse County Administrator. Administrator O'Malley has served 37 years in Public Administration with Eau Claire County, Marinette County, Rice County MN, Burnsville MN, and La Crosse County. He led 19 La Crosse County budgets and has served 111 County Supervisors from 2003-2022. A few of his major accomplishments are the Criminal Justice Reform and managing County Jail capacity, stimulating neighborhood revitalization in the most challenged neighborhoods, enhanced economic development in West Salem that expanded employment and value, development of the Administrative Center and Downtown Campus, and building replacement and cost control for the Lakeview Health Care Center.
  - All Wisconsin Counties of similar size levy more total taxes than La Crosse County and La Crosse County is the most effective in minimizing local costs to the property taxpayers of any similar sized County. The average tax levy is 28.8% of total expenditures. Year end 2021 financials are in the strongest position ever. All major capital needs have been addressed which include facilities, jail, long term care, emergency communications and federal funding for road projects.
- Status Report: Budget, Reserves, Cash Flow and Debt
  - Administrator O'Malley gave an overview of the link between the county budget, taxes and use of reserves and debt. Over 80% of the County Budget is paid by revenues other than property taxes. The General Fund reserves have historically been the source of cash flow or all fund and investment interests of reserves has been a strong source of revenue. Some of the benefits of borrowing instead of spending down reserves is it spreads capital cost over multiple budgets, debt interest rates have been lower than interest revenue received, retaining strong reserves provides contingency or "rainy day" funding, and strong reserves reassures the rating agency and investors. The 2022 gross expenditures is \$170.80 million, not including \$22.9 million in ARPA funding. The 2022 tax levy is \$36.794 million and that equals 19% of total revenue. Year End 2021 remaining principle Governmental Debt is \$53,460,000 and Year End 2021 remaining principle for Enterprise Debt is \$22,506,838. Governmental Debt is paid by property taxes and Enterprise Debt is paid by other revenue. La Crosse County has a Moody's Rating of Aa1. In every year since Highway borrowing began, the County made more cumulative interest on reserves invested than paid on total Highway debt. Highway borrowing from 2010-2021 equaled \$39.86 The average investment rate for 2010-2020 was 2.19% and the average million. borrowing rate for the same time period was 1.41%. Cumulative Investment Interest earned on the General Fund has exceeded annual interest paid to date on Highway borrowing. Year End 2021 financials are even stronger than anticipated with revenues exceeding expectations. Early 2022 sales tax receipts indicate excel revenues over budget. Recommended changes for 2022 instead of issuing debt; apply \$5 million unassigned General Fund to Highway budget and reduce the balance closer to the 50% General Fund Policy. In addition, postpone Hillview funding until 2023 without selling bonds. The project construction can begin by relying upon the ARPA funding and Hillview cash through 2022. Recommendations for the 2023 budget is to loan \$5.3 million to Hillview from the General Fund to be repaid over a 20 year amortization at 2.5% with interest only payment in 2024 and evaluate options throughout the budget to shift levy to Highway to reduce the need for debt toward funding of a new five year CIP at \$7 million/year for construction.
