- Supervisor Conference Reports
 - Supervisor Hundt announced the new Paws Park at Veteran's Park in West Salem has opened.
 - Supervisor Padesky, Kruse, Baroni, Geary, Plesha, Ferries, Konradt, Hoyer, Pierce, Isola, Erickson, and Mader all attended the WCA Conference at the Wisconsin Dells. County employees/departments who presented were the Crisis Program from Human Services, Human Services Director Jason Witt presented on Child Protection, and a presentation on diversity and inclusion.

Interim Administrator Report – Jane Klekamp PROCLAMATION OCTOBER 2022 - SOLID WASTE & RECYCLING MONTH

WHEREAS, La Crosse County helps to minimize the environmental impact of waste disposal in our region through management of award-winning programs including waste-to-energy, landfill operations, gas to energy recovery and household hazardous materials collection; and, WHEREAS, La Crosse County has helped to facilitate the successful implementation of single-stream recycling collection in the cities of La Crosse and Onalaska that has resulted in a 137 percent increase in recycling; and, WHEREAS, La Crosse County enhances regional solid waste and recycling efforts through expanding sustainability practices and collaboration on all aspects of solid waste and recycling, processing, and beneficial reuse of by-products. NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board does hereby proclaim the month of October 2022 as La Crosse County Solid Waste and Recycling Month and urges all residents to join in recognizing the valuable contribution of persons dedicated to operating one of the most environmentally sustainable solid waste disposal systems in the nation.

Motion by D. Ferries/P. Viner to approve passed on a unanimous voice vote with 28 ayes, 2 excused - R. Abraham and K. Hoyer.

- Heritage Center Update
 - o Executive Director Peggy Derrick presented a project review. A strategic planning proposal was done to determine space needs, development of theme/story/message and development of business model and operating budget opinion. Total cost will be \$120,000 with \$30,000 coming from La Crosse County Historical Society, \$60,000 from the City of La Crosse and \$30,000 from the County of La Crosse. FEH Design Architectural firm from Dubuque, IA and Lord Cultural Resources in Toronto, Canada worked in partnership on the proposal. The next step is a Fundraising Feasibility Study with Creative Fundraising Advisors to determine the fundraising capacity.
- Highlights of 2023 Administrator's Budget

o Key highlights of the budget include lower taxes, increased highway funding, reduced county debt, 3% pay increase, maintains strong and healthy reserves, and no reduction in services. The 2023 recommended mill rate is \$2.90 per \$1,000. The total levy is \$37,458,167 and total revenue is \$208,141,404. The public hearing on the budget will be held on November 14th and the budget meeting will follow.

ARPA Update

- o Neighborhood Child Care Model UW Extension Community Development Educator Charlotte Peters is developing a plan that will be shared with Supervisors. \$3.3 million was reserved for this project but \$300,000 has been reallocated to Veterans programs. Estimated date for funding request is unknown.
- o Bridge Housing for Families One group is working to acquire properties for non-profits to own and sustain into the future and anther group is developing a plan to provide ongoing case management and services for families. \$3 million was reserved for this project and estimated date for funding request is December 2022.
- Skilled Trades Training The project is going through an RFP process to ensure fairness.
 \$2.125 million was reserved and estimated funding request is 3rd guarter, 2022.
- Hillview redesign and rebuild the County is working with Hoffman Planning and Construction to design and construct the Community Based Residential Facility. Total cost is \$10.5 million with \$5 million of ARPA funding allocated and \$5.5 million in general obligation long-term debt.
- o Green Infrastructure County Solar The board is being asked to allocate \$18,320 for the consultant to help with RFP. \$1.5 million was reserved and final costs are still being determined. Board will be asked to release \$34,000 in October with final request to be made after RFP process.
- o Bridge Housing for Adults A sustainability plan in being developed and next steps include determining a location for the building. \$3 million was reserved with total cost of the project to be determined through the RFP. Estimated date of funding request is 3rd quarter, 2022.
- Grants for Housing redevelopment The grant program is ready to expand countywide.
 \$2 million was reserved and funding approved in June 2022. Two demolition grants were approved in the Town of Campbell and the next round of grant reviews will occur in January 2023.
- Stormwater Infrastructure Grant Fund A grant application process in being developed for the unincorporated areas. \$2 million was reserved with funding approved in June 2022.
 The program is currently accepting applications for both conceptual project ideas and designed stormwater projects.
- Allocation to Veterans Program Results from a survey to veterans showed the two highest priorities to be housing and economic assistance with transportation as the third priority. \$500,000 was allocated in December of 2021 and estimated date for plan approval is 4th quarter, 2022.
- Allocation to Community Events \$90,000 was allocated for community events and an application has been drafted and will be presented to the Executive Committee in October 2022.
