RE: AUTHORIZATION TO RECEIVE 2022 GRANT MONEY FROM THE STATE OF WISCONSIN DEPARTMENT OF ADMINISTRATION FOR THE WISCONSIN LAND INFORMATION PROGRAM 2022 STRATEGIC INITIATIVE GRANT.

**WHEREAS,** La Crosse County has been awarded \$60,000 through the State of Wisconsin's Department of Administration (DOA) Land Information Strategic Initiative Grant; and

**WHEREAS,** the purpose of these funds is to generate and enhance GIS (Geographic Information Systems) projects associated with the Zoning, Planning & Land Information Department; and

**WHEREAS,** potential upcoming GIS projects include updating the server; creating/updating/enhancing web applications and working with a consultant to ensure that maintained street centerlines and addresses layers are compatible with the requirements of Next Gen 911;

**NOW THEREFORE BE IT RESOLVED,** that the La Crosse County Board hereby accepts the \$60,000 in grant funding from Wisconsin DOA; and,

**BE IT FURTHER RESOLVED,** that the County Board Chair is authorized to execute any contracts or documents necessary to effectuate the purposes of this resolution, after approval by Corporation Counsel; and,

**BE IT FURTHER RESOLVED,** that the Finance Department is authorized to make any necessary and appropriate budget adjustments relating to accepting this additional state funding.

**FISCAL NOTE:** Total grant award is \$60,000, with no County match required, and the award period ending December 31, 2023. The operating costs will be tracked under the 270.675.1000 division within the County financial system and overseen by the Zoning Department.
