WHEREAS, the nation's 3,069 counties serving more than 330 million Americans provide essential services to create healthy, safe and vibrant communities; and WHEREAS, counties fulfill a vast range of responsibilities and deliver services that touch nearly every aspect of our residents' lives; and WHEREAS, La Crosse County and all counties take pride in our responsibility to protect and enhance the health, wellbeing and safety of our residents in efficient and cost-effective ways; and WHEREAS, under the leadership of National Association of Counties President Denise Winfrey, NACo is highlighting how "Counties RISE!," demonstrating exemplary Resiliency, Inclusion, Solvency, and Empowerment; and WHEREAS, each year since 1991 the National Association of Counties has encouraged counties across the country to elevate awareness of county responsibilities, programs and services; and WHEREAS, La Crosse County employees work to protect and strengthen community in all parts of our county through programs that improve public infrastructure and create opportunities for people and businesses to thrive. NOW, THEREFORE, BE IT RESOLVED, that the La Crosse County Board does hereby proclaim April 2023 as National County Government Month and encourages the public to recognize the contributions county governments make to improving the quality of life for all.

• General Update

O Sara Koopman has been hired as the Associate Administrator and will start on May 1st. Administrator Klekamp has been meeting with various town/village/city officials to build a relationship and will now have regular meetings with them. She will have monthly conversations with WIZM on their radio show. The Hillview project will be brought back in July, Skilled Trades Training proposal has been received and will be reviewed, MOU for Bridge Housing will go to the Executive Committee, Solar Energy resolution will come this month, and the Childcare Grants process is being developed. Preparations for the 2024 budget has begun and one concern is the jail workers being granted protective status which could have an affect on the budget.

- County Solar Update Conservation Specialist Jacob Schweitzer, County Planner Dillon Constant, and Aaron Benson of Solar Connection presented.
 - o Jacob Schweitzer reviewed the steps that got the Solar Project to this point. \$1.5 million was set aside, projected sites were chosen, site visits by contractors, bids for RFP and the solar installation project is projected for 2023. La Crosse County solar array would provide long-term impacts by reducing energy costs and CO2 emissions for La Crosse County and into the future. The energy usage and each site with pricing was reviewed. The total bid for all sites is \$1,847,034. There is a Focus on Energy Grant amount of \$104,942 and an Inflation Reduction Act tax credit on the project of \$522,267. The final project cost will be \$1,219,464.
- Town of Campbell Water Report Town of Campbell Supervisor Lee Donahue and UW Extensions Karl Green presented.
 - La Crosse County donated \$100,000 with matching funds from the Town of Campbell which allowed for the drilling of a test well in 2022. This was key in finding out if the deep aquifer is a long-term solution to the contaminated water. The testing showed the deep aquifer is safe and is a sustainable water source. The three shallow wells are contaminated but the deep well has consistently shown non levels of PFAS. The study will show if PFAS plumes currently found on French Island migrate in regional aquifers or will in the future and do the PFAS plumes have the potential to contaminate the deeper Mt. Simon aquifer and/or communities outside Campbell. The study will also deliver a sentry well with the ability to monitor PFAS transport in the shallow and deep aguifers, an improved map of the extent and properties of the Eau Claire confining unit including direct samples and geophysical surveying within the river valley, and an updated and refined model for the La Crosse County region to predict PFAS movement in the upper and lower aquifer. La Crosse County will benefit by supporting safe, long term sustainable drinking water sources for Campbell and adjacent communities, model and monitor PFAS movement in the shallow and deep aguifers in the region, updated regional maps showing extent and protective qualities of various rock formations between aquifers, and develop protocols to safeguard water supplies in the region.
