- Chair Kruse, Corporation Counsel Megan DeVore and Administrator Jane Klekamp attended the WCCMA – Wisconsin City County Management Association. Discussion was on navigating management challenges.
- o Supervisor Schlimgen attended Chief Inspector Training and encouraged Supervisors to recruit poll workers.
- Supervisor Tryggestad noted the Homeless Person Memorial will be held on December 21st which is the longest night of the year. The service will be held at 1pm at the Reach Center.

Administrator Report - Jane Klekamp PROCLAMATION DECEMBER 2023 - ZONING, PLANNING AND LAND INFORMATION AND METROPOLITAN TRANSPORTATION PLANNING MONTH

WHEREAS, the staff of these departments assist and advise individuals, businesses, professionals, and governmental units in administering zoning, floodplain, shoreland, subdivision, telecommunication, and nonmetallic mining ordinances; and, WHEREAS, they coordinate land information systems for the assessment, taxation, mapping, permitting, planning and educational needs of the public and private sector, including through the county land records website; and, WHEREAS, they help provide transportation planning to develop and obtain funding for safe and efficient transportation networks throughout our region. NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board does hereby proclaim the month of December 2023 as Zoning, Planning and Land Information and Metropolitan Transportation Planning Month in recognition of the contributions of staff dedicated to promoting planned and orderly land use development for the benefit of all.

Motion by K. Hoyer/R. Cornforth to approve passed on a unanimous voice vote with 26 ayes, 4 excused - R. Abraham, K. Cable, J. Poley and A. Richmond.

General Update

- o Administrator Klekamp noted that the County was recently hacked and the IT Department was able to stop it and minimize the damage; Hillview planning was approved with designing in the 2nd quarter next year and construction to begin in the 3rd quarter; Wisconsin has a WI Caregiver Program that trains people to be Certified Nursing Assistants in the nursing homes and then reimbursed by the State of Wisconsin, 15 people have been trained with this program; the Operations Coordinator at Solid Waste, Jackie Davis, received the Future Five Award from the La Crosse Chamber of Commerce; the County Clerk was invited to Atlanta, GA with about 20 other election officials to discuss the possible 2024 election threats and how to manage them.
- Report on Family Bridge Housing Anna Sprague Couleecap, Kevin Burch Catholic Charities, Isaac Hoffman - Director of the La Crosse Area Family Collaborative and Hetti Brown - Executive Director of Couleecap.
 - The goal was to add 16-20 units total with 2/3 purchased by the end of 2024. Average cost of \$175,000/unit for purchase price and necessary repairs. Catholic Charites has purchased properties that include a single family 2-bedroom home on the northside for \$110,185 with occupancy for March 2024; single family 4-bedroom on southside for \$200,185 with occupancy for February 2024; single family 3-bedroom home on the southside for \$160,185 with occupancy at the end of the week; single family 4-bedroom home on the southside for \$147,000 with closing in 2 weeks and occupancy in July 2024. Their current funding used is \$470,555 for the purchasing of properties and \$36,000 in estimated repairs for upcoming northside home. Couleecap has purchased properties that include a single family 2-bedroom home on the northside of La Crosse for \$180,000. A family of four moved into this home in November. They also purchased a duplex with 3bedroom units on southside of La Crosse for \$300,000 and will be ready for occupancy by January 2024. Their current funding used is \$480,000 in properties purchased, \$12,893 in repairs and \$7,611.01 in other expenses. Isaac Hoffman reviewed the types of families that are targeted for this program and the services being offered to them to encourage success.
