### RE: CHANGES IN POSITIONS FUNDED BY OUTSIDE SOURCES (NON-TAX LEVY) FOR 2024

**WHEREAS,** the County Administrator's 2024 budget includes changes in positions that are fully funded by outside sources; and,

**WHEREAS,** new positions of 2.00 FTE are the result of increased grant revenues and other outside sources and a reduction of 0.79 FTE as a result of decreased grant revenues and other outside sources,

**NOW THEREFORE BE IT RESOLVED,** that the following position modifications be approved for inclusion in the 2024 La Crosse County budget, reflecting a net increase of 1.21 FTE with \$0 levy impact.

**BE IT FURTHER RESOLVED,** that the Finance Department is authorized to make the necessary changes to the budget as needed and the Human Resources Department is authorized to make necessary changes to the County pay plan.
