WHEREAS, the County Board has reviewed and considered modifications of the salary for the elected positions of County Clerk, County Treasurer and Register of Deeds pursuant to Wisconsin State Statutes and;

WHEREAS, salaries for the Sheriff and Clerk of Courts 3% for all four years of their term of office.

BE IT FURTHER RESOLVED, that, in addition to the above compensation, the elected officials shall also pay, as required by state law, 50% of the elected officials Wisconsin Retirement System contribution, and such changes from year to year as set by the state and WRS, and;

BE IT FURTHER RESOLVED, that the elected officials shall be eligible for voluntary health, dental and life insurance subject to the same terms and conditions as full-time non-represented La Crosse County employees.

FISCAL NOTE: The estimated cost of salary for 2025 is \$276,261 and rollups (FICA, MED, WRS) of \$40,196. All elected officials are contributing 6.9% to the WRS for 2024.
