populations which include children, adults and children with disabilities, the aging, and people dealing with mental illness; and, **WHEREAS**, to serve and help individuals in need, county human services professionals routinely enter homes and travel to other locations in the community, at times facing volatile situations and safety risks; and, **WHEREAS**, Family Court and Mediation and Family Court Services strive to maintain the dignity, safety, and security of families going through difficult transitions; and, **WHEREAS**, the individuals and the entire community benefit from the investment in lives that human services and family court professionals make every day; and, **NOW THEREFORE BE IT RESOLVED**, that the La Crosse County Board does hereby proclaim the month of March 2024 as Human Services and Family Court Month and urges all citizens to join in recognizing the valuable contribution of Human Services and Family Court staff.

- Hillview Project Update
 - An update on the Hillview project was presented by Hoffman. The schedule is to have the designing done by mid-2024, have bids go out in June and July and construction beginning in August 2024. The estimated completion date is September 2025. Some of the complexities and hurdles they are facing are the new DHS CBRF regulations, day center space exceptions for programming, balancing the wish list scope and continues search for efficiencies. Layouts and models of the new design were reviewed. The CBRF is planned for 35 beds with an open concept and efficient operations. The crisis stabilization will have 4 beds for secure housing in a safe environment. The skilled nursing will have 26 existing beds with kitchen upgrades. Support housing will have 10 apartments with a social environment and independent amenities. The intergenerational day center will have adult and child programming with a safe entrance.
