RE: TO SUPPORT INTERNET SERVICE PROVIDERS BEAD FUNDING APPLICATIONS FOR BROADBAND INFRASTRUCTURE DEVELOPMENT

WHEREAS, in 2023, La Crosse County became certified through the Wisconsin Public Service Commission as a Broadband Forward! and Telecommuter Forward! Community; and

WHEREAS, in 2023, the State of Wisconsin was awarded \$1,055,823,573.71 from the National Telecommunications and Information Administration through the Infrastructure Investment and Jobs Act; and

WHEREAS, The Wisconsin Public Service Commission has opened round 1 of BEAD funding for internet service providers; and

WHEREAS, applications may require support from local units of government, including county government, which must be completed by January 19, 2025, and

WHEREAS, La Crosse County is committed to work with internet service providers to support projects throughout all of La Crosse County.

NOW, THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby authorizes the Board Chair to author and submit letters of support on behalf of the County Board to endorse internet service providers BEAD funding applications.

FISCAL NOTE: There is no cost to La Crosse County. Any recommendations related to this initiative that will have a financial impact will be considered in future board action.
