#### **RE: CHANGES IN GENERAL OPERATING LEVY POSITIONS AND HOURS FOR 2025**

**WHEREAS,** based on input from the departments, the County Administrator's 2025 budget includes a total decrease of 2.10 Full Time Equivalent (FTE) and an increase of 1.67 FTE for positions supported by local property tax levy.

**NOW THEREFORE BE IT RESOLVED,** that the following position modifications be approved for inclusion in the 2025 La Crosse County budget, reflecting a net decrease of 0.43 FTE with a potential decrease of \$98,579 in the 2025 Tax Levy.
