General Update

o 67 veterans work for the County in 16 different departments; a thank you to the election workers who be working late tomorrow and the County staff who will be helping out by working the polls tomorrow; 64 Trane employees spent a day at Hillview helping with outdoor projects; the Health Department and Sheriff's Office collected 64 pounds of prescriptions drugs on "Drug Take Back Day"; the Sheriff's Office held a drive to collect items for the victims of the hurricanes; La Crosse County received recognition from LADCO for their work on the Holmen Industrial Development; Jenna Helminski Juve received recognition as A Rising Star Under 40 from the 7 Rivers Alliance and the River Valley Media Group; and Maomaoua Vue won the YWCA Tribute to Outstanding Woman in the eliminating racism category.

Administrator Work Plan Self-Assessment

Administrator Klekamp gave an overview of her report. Three areas of focus for the County are Board Collaboration and Communication, Leading the County, and Countywide Economic Growth and Vitality, Environmental Stewardship, Healthy initiatives. Infrastructure, Robust Support Network, Sustainable and Affordable Housing, Inclusive Community, and Engaged and Empowered Employees are all part of the Strategic Plan Outcome Measures. She assists with planning and presenting board orientation and provide reports to the Executive Committee. She also leads the County by leading departments and the fiscal team in developing a budget, using the County Board Strategic Plan to inform work at the department level, transition some direct reports to the Associate County Administrator, and continue the implementation of Leadership and Cultural Competencies for all county leaders. Countywide initiatives being worked on include Diversity Equity & Inclusion plan implementation, begin Strategic Plan integration, prepare nonexempt/hourly wage implementation plan for county board review and approval, establish process for Opioid Settlement Planning, and revise and develop a more detailed capital improvement plan.
