PROCLAMATION NO. 213-9/24 SEPTEMBER 2024 - LIBRARIES & UW EXTENSION MONTH WHEREAS, research-based educational programs for agricultural producers, businesses, local governments, communities, families and youth are brought to the residents of La Crosse County; and, **WHEREAS,** library programs identify and respond to specific community needs for education and knowledge to improve the quality of life in local communities; and **WHEREAS** libraries provide

knowledge to improve the quality of life in local communities; and, **WHEREAS**, libraries provide recreational and educational resources for residents in pursuit of life-long learning and provide community gathering places for all; and, **WHEREAS**, UW-Extension programming combines faculty, campus-based specialists, and staff expertise to bring university research to the people of La Crosse County in the areas of Agriculture/Horticulture; Community, Natural Resources and Economic Development; Family Living Education; and 4-H & Youth Development; and, **WHEREAS**, UW-Extension faculty and staff and area library staff are committed to educating the residents of La Crosse County to promote life-long learning to develop a more knowledgeable and informed community. **NOW THEREFORE BE IT RESOLVED**, that the La Crosse County Board does hereby proclaim the month of September as La Crosse County Libraries and UW-Extension Month.

ADMINISTRATOR'S REPORT

Motion by J. Pogreba/D. Ferries to approve passed on a unanimous voice vote with 26 ayes, 1 absent - P. Scheller, 3 excused - E. Anderson, D. Balduzzi and S. Doyle.

- General Update
 - Administrator Klekamp noted the libraries started using a new catalog app that is available to all the libraries in the County; Dayforce started this week; a new property tax software went into effect last week; the Health Department is giving vaccines to adults who don't have insurance on October 3rd at St. Clair's Health Mission; the groundbreaking for Hillview will be on October 2nd; the City of La Crosse has approved everything that is needed for the Hillview remodel to start; Private Robert L Skaar, who lived in La Crosse, will be buried with gravesite services on October 1st, 2024 at 9am at Woodlawn Cemetery in the Veterans Cemetery. He enlisted when he was 18 years old and was killed in action on March 8, 1945. His remains were identified on June 7th, 2024.
- Background on Mental Health Resolution
 - Human Services Director Jason Witt gave some background information on the resolution coming before the board later tonight on mental health funding. Counties are mandated to cover certain mental health costs but funding for Human Services has been challenging. This resolution calls on the State to increase funding in nonfederal share of crisis services and the nonfederal share of community support programs.
- Overview of 2025 Budget Process and Initial Recommendations
 - The budget is a balancing act between providing strong county services while working within constraints of levy limits and outside funding sources. Highlights include a \$206 million balanced budget, maintains and strengthens county services, 3% raise for staff and no increase in health premiums, total levy for 2025 is decreasing .03%, no borrowing for ongoing capital needs, and the County debt continues to fall. Consideration on the budget include sales tax growth that is slowing, out of home care costs are running \$1.1 million over budget, increase in shared revenue of \$109,000, workforce turnover generated \$5 million in savings, and investment income trending \$1 million over budget. The 2025

budget has a total revenue of \$205,950,342 which comes from fund balance, long term borrowing, sales tax, public charges, federal and state, property tax and miscellaneous. Expenditures include debt service, health, library, highway, solid waste, human services, long term care, and general government. The 2025 recommended budget has total levy of \$37,909,714. The average mill rate per \$1,000 is \$2.55. Total County debt continues to decline. There will be record highway funding of \$14.1 million which will support 11 miles of construction work and 20 to 25 miles of chip sealing. A second budget presentation will happen at the October 17th Monthly meeting with a public hearing and vote on the budget at the November 12th Annual meeting.

RESOLUTION NO. 14-9/24 RE: SUPPORT OF STATE INVESTMENT FOR MENTAL HEALTH FUNDING

WHEREAS, La Crosse County is concerned that the public mental health system in Wisconsin is in need of additional resources to respond appropriately to the needs of individuals with persistent mental illness and those experiencing a mental health crisis; and WHEREAS, state law designates counties with the responsibility for the well-being, treatment, and care of individuals with mental illness, and serving those without private insurance coverage; and WHEREAS, the Medical Assistance program (MA) covers an array of mental health services, ranging from office-based therapy to inpatient hospitalization, and many of these services are delivered by counties; and WHEREAS, Community Support Programs (CSP) offer intensive community-based care for adults whose mental illness and functional limitations might otherwise require them to need institutionalized care. Counties use CSP services to keep people out of extended hospitalizations and support people in the community following emergency detentions; and WHEREAS, counties are required to provide Crisis intervention services including an emergency mental health services program to serve persons in crisis situations; at a minimum, 24-hour crisis telephone service and 24-hour in-person response on an on-call basis; and WHEREAS, while the state pays the full cost of most MA services, when it comes to county-based CSP and Crisis mental health services, the county finances the cost of the services up front, and receives MA reimbursement for only the federal share for that service, and **WHEREAS**, Community Aids funding has not kept pace over the years with increased county costs for services, resulting in counties bearing a disproportionate share of CSP and Crisis service costs from county tax levy; and WHEREAS, counties are limited in their capacity to use tax levy revenue due to state levy limits, so the lack of Community Aids increases combined with strict property tax controls makes it difficult for counties to maintain Crisis and CSP services; and WHEREAS, in addition to the costs to county human service departments, counties and municipalities also incur law enforcement costs to transport and provide security for persons in a crisis; and WHEREAS, the awareness of the 988 National Suicide & Crisis Lifeline has made mental health assessment and referral more readily available, resulting in more demand on the mental health crisis systems; and **WHEREAS**, stagnant state funding results in variations in the extent of services available across counties, wait lists for services, and eligible people receiving limited services; and WHEREAS, the limited state funding for Crisis services makes it difficult for counties to implement new evidence-based services, such as mobile crisis workers that could meet law enforcement officers in the field for crisis calls, that would reduce the need for law enforcement involvement and provide a more trauma-informed response to crisis situations, and; WHEREAS, Wisconsin's counties continue to cover the costs of mental health services for individuals who are not Medicaid eligible, and; **NOW**, **THEREFORE**, **BE IT RESOLVED**: that the La Crosse County Board of Supervisors does hereby request that the state of Wisconsin, in its 2025-27 state biennial budget, provide state GPR funding to cover the full non-federal share of MA CSP and Crisis services, and; **BE IT FURTHER RESOLVED**, that the La Crosse County Clerk is hereby authorized and directed to send a copy of this Resolution to the Governor of the State of Wisconsin, Wisconsin State Legislators with a constituency within La Crosse County, and the Wisconsin Counties Association. **FISCAL NOTE:** La Crosse County Human Services' Crisis program is tracked in the 210.445.1000 division and the Community Support Program is tracked in the 210.455.4750 division within the County financial system.

RESOLUTION NO. 15-9/24 RE: AUTHORIZING AND APPROVING THE PROJECT PLAN AND PROGRAMMATIC ENVIRONMENTAL IMPACT STATEMENT (PLAN-PEIS) PREPARED BY THE NATURAL RESOURCE CONSERVATION SERVICE WHICH RECOMMENDS DECOMMISSIONING ALL FOURTEEN PL-566 WATERSHED DAMS IN THE COON CREEK WATERSHED

WHEREAS, on the night of August 27, 2018, seven Watershed dams overtopped. Three dams failed in Monroe County. Rainfall amounts up to eleven inches were reported in the evening of August 27 and early morning hours of August 28, 2018, which led to the failure of the dams; and **WHEREAS**, the

contributing watershed areas for these dams reside in La Crosse, Monroe, and Vernon Counties; and **WHEREAS**, two dams reside in La Crosse County, seven dams reside in Monroe County, and five dams reside in Vernon County, and they function as a system to provide flood prevention and flood damage reduction benefits in the Coon Creek valley; and WHEREAS, the Project Sponsors, La Crosse, Monroe, and Vernon Counties, requested a PLAN-PEIS from the Natural Resource Conservation Service (NRCS) to evaluate the stability, effectiveness, and socio- economic and environmental effects associated with the Watershed dams; and WHEREAS, the NRCS has completed the PLAN-PEIS; and WHEREAS, the preferred alternative in the PLAN-PEIS recommends the decommissioning of all fourteen Watershed dams; and **WHEREAS**, the preferred alternative in the PLAN-PEIS has a satisfactory benefit to cost ratio and reduces risk to people and property from future dam failures; and WHEREAS, the Project Sponsors acknowledge and accept the public participation (scoping) process in the preparation of the PLAN-PEIS; and **NOW**, **THEREFORE**, **BE IT RESOLVED** that the La Crosse County Board of Supervisors accepts the PLAN-PEIS in collaboration with Monroe County and Vernon County and agrees to enter into a Watershed Agreement with the U.S. Secretary of Agriculture through the NRCS for dam decommissioning in the Coon Creek Watershed in accordance with the terms, conditions, and stipulations provided in the PLAN-PEIS. BE IT FURTHER RESOLVED that the La Crosse County Board of Supervisors does hereby also agree to provide the necessary staff to work with affected landowners on the final disposition of properties affected by dam decommissioning and assist the NRCS with incorporating landowner concerns into the final engineering plans. BE IT FURTHER RESOLVED that the La Crosse County Board of Supervisors does hereby authorize the Natural Resource Conservation Service to secure a grant to hire a private engineer to complete the designs to facilitate this decommissioning of the above referenced dams. FISCAL NOTE: Staff time is budgeted in Land Conservation division 100.205.1000 within the County financial system. There is no other direct fiscal impact to La Crosse County at this time.

The Committee, under s., Wis. Stats., along with the affected Town Board(s), under s. 17.10(8), have the authority to approve the application with integral conditions or to disapprove of the application. Having considered the entire record, the Committee's recommendation is to: By a vote of SIX (6) in favor (Hoyer, Pierce, Rothering, Scheller, Isola, Jacobsen), ZERO (0) no, and ONE (1) (Schlimgen) abstentions, the committee recommended Approval of CONDITIONAL USE PERMIT No. 1246 subject to the following THREE (3) conditions:

- 1. The owner(s) of the property to which this Conditiona Use Permit is issued will abide by all representations and commitments made during the permitting process as well as before the Committee, in accordance with all conditions to the conditional use permit, taken as a whole, as approved by the Planning Resource and Development Committee and the County Board.
- 2. This approval does not preempt permittees' obligation to comply with all other applicable federal, state, and local regulations.
- 3. Prior to the issuance of a Zoning Permit, the applicant shall file a financial assurance with the Zoning, Planning, and Land Information Department based upon a written estimate of the cost to remove said structures from a qualified remover of, or an engineer with experience estimating costs of removing said types of structures, less the estimated salvage value, or twenty thousand dollars (\$20,000), whichever is less, to guarantee that solar energy system structures will be removed following two consecutive years of discontinued use. Financial assurance may include but are not limited to certificates of deposits, irrevocable letters of credit, irrevocable trusts, established escrow accounts, government securities, or demonstration of financial responsibility by meeting net worth requirements and shall be payable exclusively to La Crosse County. The County may require an increase in the financial assurance amount after five (5) year intervals to reflect increases in the Consumer Price Index, but at no time shall the financial assurance amount exceed twenty thousand dollars (\$20,000). The provider shall supply any increased financial assurance within a reasonable time, not to exceed sixty (60) days after the County's request. A permittee may submit a letter of credit in the amount set forth above, or as an alternative, a permittee with several sites within La Crosse County may submit a master bond to cover all of said sites. A master bond or letter of credit may, at the Planning, Resources and Development Committee's discretion, be in an amount sufficient to secure removal from the site if the master bond or letter of credit provides for replenishing any amount used as the master bond or letter of credit covers any other site in the County.
