# RESOLUTION NO. 1-4/25 RE: URGING CONGRESS TO NOT MAKE DRAMATIC CUTS TO MEDICAID AND THE OLDER AMERICANS ACT FUNDING IN THE PROPOSED RECONCILIATION BILL

WHEREAS, members of Congress are considering which of the substantial cuts in federal Medicaid program will be included in a reconciliation bill; and **WHEREAS**, the reconciliation bill may move rapidly through Congress before details of the cuts are fully understood and before the public and members of local government have the opportunity to provide feedback regarding the impact of the cuts; and WHEREAS, cuts to Medicaid could significantly reduce Medicaid reimbursements to the county for mandated programs such as Children's Long-Term Support, Adult Family Care, and long-term elder care; and WHEREAS, La Crosse County provides specialized skilled nursing services primarily funded through Medicaid for over 135 years to individuals with complex needs; and WHEREAS, La Crosse County provides WIC (Women, Infants, and Children) services to children and families who are often adjunctively eligible due to participation in Medicaid funded programs, specifically BadgerCare Plus. WHEREAS, Federal Medicaid funding cuts will leave states and counties with a negative impact on their budgets as costs would become the responsibility of the state or county. These cuts would impact the ability to provide services for the disabled, elderly, or mentally ill; and WHEREAS, cuts to Medicaid and the Older Americans Act programs will hurt vulnerable individuals and families, workers who provide these services, and the healthcare and crisis workers when citizens experience health crises; and WHEREAS, Aging and Disability Resource Center's (ADRCs) in Wisconsin offer a strong return on investment while significantly

enhancing the well-being of individuals across the state. In 2023, every \$1 invested into ADRCs in Wisconsin led to a savings of \$3.88; and **WHEREAS**, Older Americans Act funding is necessary to continue the senior nutrition program, that includes home delivered meals and congregate dining. **NOW THEREFORE BE IT RESOLVED**, the La Crosse County Board of Supervisors requests and urges elected representatives to preserve Medicaid and Older American Act funding in budget reconciliation bills. The La Crosse County Board of Supervisors to reject proposals that reduce federal Medicaid and Older Americans Act funding; and **BE IT FURTHER RESOLVED**, a copy of the resolution shall be sent to Wisconsin state and federal legislators and the Wisconsin Counties Association. **FISCAL NOTE:** No fiscal impact to La Crosse County.

**RESOLUTION NO. 2-4/25 RE: SUPPORTING THE INCLUSION OF THE PRAIRIE SPRINGS** SCIENCE CENTER COMPLETION PROJECT IN THE 2025-2027 STATE BIENNIAL BUDGET **WHEREAS**, the University of Wisconsin-La Crosse (UWL) has experienced consistent enrollment growth over the past decade, establishing itself as a high-demand institution among the Universities of Wisconsin campuses, with a strong capacity to fill critical labor shortages in the State of Wisconsin and the La Crosse region; and WHEREAS, the Prairie Springs Science Center Completion Project aims to increase UWL's capacity to educate students in crucial fields connected to healthcare, manufacturing, food processing, and education, which are vital to our regional and state workforce; and **WHEREAS**, the completion of the Prairie Springs Science Center will provide instructional spaces of varying capacities, from smaller classrooms seating 25 students to larger lecture spaces accommodating up to 150 students, in addition to collaborative spaces that will foster student engagement, research, and innovation; and WHEREAS, the Prairie Springs Science Center will replace the outdated Cowley Hall, a 54-year-old facility that no longer meets the educational and technological standards which are valued in contemporary science, technology, and math instruction; and WHEREAS, the estimated project budget, requested at approximately \$186 million in the 2023-2025 biennial budget, includes the demolition of Cowley Hall and construction of new facilities, thereby addressing critical space, functionality, and safety needs for current and future UWL students; and WHEREAS, UWL is actively collaborating with local economic and industry partners, including employers and manufacturers in La Crosse County, to align educational programming and planning with workforce needs, thus strengthening the economic foundation of our community and fostering opportunities for students to connect with regional employment pathways; and **WHEREAS**, the approval of this project would infuse state funds into our local economy, enhance UWL's role as a key local economic engine, and support the preparation of students for high-demand jobs in our communities and workforce; **NOW, THEREFORE, BE IT RESOLVED,** that the La Crosse County Board supports the inclusion of the Prairie Springs Science Center Completion Project at the University of Wisconsin-La Crosse in the 2025-2027 State Biennial Budget; and **BE IT FURTHER RESOLVED**, that a copy of this resolution be forwarded to Governor Tony Evers and the La Crosse state legislative delegation. **FISCAL NOTE:** No fiscal impact.

## ORDINANCE NO. 218-4/25 TO AMEND S. 4.02, "SALE OF TAX DELINQUENT REAL ESTATE" OF CHAPTER 4 ("FINANCE") OF THE GENERAL CODE OF LA CROSSE COUNTY, WISCONSIN

The County Board of Supervisors of the County of La Crosse does ordain as follows:

- **Section 1.** Section 4.02 is amended to read:
  - 4.02 SALE OF TAX DELINQUENT REAL ESTATE.
    - (1) ELECTION TO PROCEED UNDER S. 75.521, WIS. STATS., IN RELATION TO THE ENFORCEMENT OF COLLECTION OF TAX LIENS. From and after February 18, 1982, the County elects to adopt the provisions of s. 75.521, Wis. Stats., for the purpose of enforcing tax liens in this County in the cases where the procedure provided by such section is applicable, and the County Treasurer need not, thereafter, proceed upon its tax sale certificates in cases where such section is applicable in any of the other methods provided by Ch. 75, Wis. Stats., or its charter provisions, but may do so at his or her option.
    - (2) CHARGES FOR IN REM FORECLOSURES. In all cases where the County elects to enforce tax liens pursuant to s. 75.521, Wis. Stats., or any amendments thereto, a charge for the fees and costs incurred by the County in foreclosing the tax lien shall be assessed as a redemption cost and shall be determined by the County Board, subject to change from time to time.
    - (3) DEFINITIONS. The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except when the context clearly indicates a different meaning:

(a)**Beneficiary** shall have the meaning ascribed to such term in Wis. Stat. § 851.03 (b)**Heir** means any person, including the surviving spouse, who is entitled under the statutes of intestate succession to an interest in property of a decedent. [See Wis. Stat. § 851.09]

(c)**Owner-Occupied, Single-Family Residence** means any single-family residential unit used by one family which owns the property as their permanent and primary residence and, upon request, is able to provide the County Treasurer with evidence establishing the satisfaction of these terms (*e.g.*, a utility bill.)

(d)**Tax-deeded lands** shall have the meaning ascribed to such term in Wis. Stat. § 75.35(1).

- (4) ADMINISTRATION AND MANAGEMENT OF TAX-DEEDED LANDS
  - (a) The County shall comply with the provisions of Wis. Stats. §§ 75.35, 75.36 and 75.69 in the disposition of tax-deeded lands.
  - (b) Pursuant to Wis. Stat. § 75.35(2)(d), the County Board of Supervisors hereby delegates to the County Treasurer the power to acquire, manage and sell taxdeeded lands including the power to determine which properties to acquire
  - (c) Within 20 days of the County's acquisition of a tax-deeded land, the Treasurer shall notify the former owner, by registered mail or certified mail sent to the former owner's mailing address on the tax bill, that the former owner may be entitled to a share of the proceeds of a future sale of the tax-deeded land.
  - (d) Within 120 days of the County's acquisition of a tax-deeded land, the Treasurer shall determine the appraised value of the tax-deeded land. The appraisal may be made by a certified appraiser as defined in Wis. Stat. § 458.01(7).
  - (e) The following provisions in this Section (e) relate to tax-deeded lands that are owner-occupied, single-family residences. This Section (e) may, in the sole discretion of the Treasurer be applied to tax-deeded lands that are not owneroccupied, single-family residences.
    - 1. Within 60 days of the County's acquisition of a tax-deeded land, the Treasurer shall provide notice to the former owner, the former owners heirs or the former owners beneficiaries right to repurchase the tax-deeded land. Such notice shall be mailed to the former owner's last known address on file with the Treasurer.

- 2. If a former owner of tax-deeded land, or such former owner's heir or beneficiary, notifies the Treasurer of an intent to repurchase the tax-deeded land within 90 days of the date the County acquired the tax-deeded land, the Treasurer shall order a title report from a title insurance company showing all liens of record against the tax-deeded land in existence on the day prior to the judgment of foreclosure in favor of the County, the cost of which shall be paid in advance by the person notifying the Treasurer of the intent to repurchase the tax-deeded land.
- 3. If the former owner, or such former owner's heir or beneficiary, provides proof of satisfaction of all liens of record as established in the title report within 30 days of the date of the title report, the Treasurer shall convey the tax-deeded land to the former owner, or such former owner's heir or beneficiary, by quit-claim deed provided the former owner, or such former owner's heir or beneficiary, has provided the County with funds necessary to satisfy all costs and expenses due the County as provided in Wis. Stat. § 75.35(3).
- (f) Unless a tax-deeded land is repurchased under Section (4)(e), within 240 days of the County's acquisition of a tax-deeded land or 180 days for tax-deeded lands acquired on or after January 1, 2026 the Treasurer shall publish on the County's website and either (i) publish a class 1 notice or (ii) advertise on a multiple listing service the availability of a tax-deeded land for purchase and the appraised value of the tax-deeded land, as determined in Section (4)(d). The publications shall include information regarding the method of sale to be utilized.

Section 2. This Ordinance shall take effect the day after passage and publication.

### **RESOLUTION NO. 3-4/25 RE: URGING GOVERNOR EVERS AND THE WISCONSIN LEGISLATURE TO SUPPORT THE COUNTY COURTS**

WHEREAS, in 2023, the total cost to Wisconsin Counties for running all Circuit Courts was \$237 million. At the same time, the Court Support funding from the state to counties was \$28 million, 12 percent of the actual cost to run the local courts; and, WHEREAS, the Circuit Court system is intended to be a state-county partnership; and WHEREAS, the state's fiscal responsibilities include Judges, Court reporters, CCAP equipment, and the Circuit Court Cost Appropriation; and, WHEREAS, the Counties are fiscally responsible for the majority of other functions of the court, including, but not limited to the following: bailiffs and court security officers, courthouse building maintenance, phones and utilities, Clerk of Court and Register in Probate, staff salaries and benefits, jury costs, psychological exams, guardians ad litem and court-appointed attorneys, expert witnesses, interpreters and translation fees, court commissioners, law libraries, corporation counsel, courtroom technology and audio visuals, copying machines and other non-CCAP office technology, office supplies, furniture, recruitment and training, financial collection efforts, mail fees, printing costs, exhibit and file storage, access to state data, insurance, service of court documents, judicial staff attorneys, and equipment repair; and, WHEREAS, over the last 10 years, the increase in the county portion of cost to run the courts is nearly six times higher than the increase in Circuit Court Cost Appropriations provided to cover these costs, and counties now pay almost \$150,000,000 more than the state in unbalanced Circuit Court costs. NOW THEREFORE, **BE IT RESOLVED**, by the La Crosse County Board of Supervisors that La Crosse County joins the Wisconsin Clerks of Circuit Court Association (WCCCA) and the Wisconsin Counties Association (WCA) in their efforts to increase the Circuit Court Cost Appropriation by \$70 million payable to Wisconsin Counties in the 2025/27 Wisconsin State Budget. BE IT FURTHER RESOLVED, that this Resolution shall be effective upon its passage and publication and a copy be sent to Governor Evers and all Wisconsin State Legislators representing La Crosse County. **FISCAL NOTE:** No fiscal impact.
