**RE: APPROVAL OF MISSISSIPPI VALLEY CONSERVANCY REQUEST FOR BLUFFLAND
FUNDING FOR PHASE II OF KAPLAN TRACT PRAIRIE AND SAVANNA RESTORATION
PROJECT**

WHEREAS, the County approved the "Blufflands Plan" in 2016 to guide a regional approach to the conservation and recreational use of area blufflands; and,

WHEREAS, the County signed a Memorandum of Understanding in September of 2021 to join the Blufflands Coalition to facilitate the implementation of the "Blufflands Plan"; and,

WHEREAS, County staff has developed "Guidelines for Requesting Blufflands Funding" to provide a consistent way for community organizations and municipalities within La Crosse County to request funding assistance for blufflands projects from the County; and,

WHEREAS, the County has received a request from the Mississippi Valley Conservancy for \$10,000.00 to help with Phase II of the Kaplan Tract Prairie and Savanna Restoration Project, and that the request follows the guidelines for requesting funding and meets all the requirements that the County has set for providing funding.

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby approves the contribution of \$10,000.00 to the Mississippi Valley Conservancy to assist with Phase II of the Kaplan Tract Prairie and Savanna Restoration Project; and,

BE IT FURTHER RESOLVED, that the County Board Chair, after approval by Corporation Counsel is hereby authorized to execute a grant agreement with the Mississippi Valley Conservancy to ensure that funds will be used to assist in Phase II of the Kaplan Tract Prairie and Savanna Restoration Project.

FISCAL NOTE: This \$10,000.00 contribution will be paid from Account 100.130.1190.63100.00 Economic Development Bluffland Protection. That account currently has \$193,600.00 which has been budgeted in previous years and carried forward in 2025.
