**RE: APPROVAL OF VILLAGE OF HOLMEN REQUEST FOR BLUFFLANDS FUNDING FOR
HOLLAND BLUFF MULTI-USE TRAIL**

WHEREAS, the County approved the "Blufflands Plan" in 2016 to guide a regional approach to the conservation and recreational use of area blufflands; and,

WHEREAS, the County signed a Memorandum of Understanding in September of 2021 to join the Blufflands Coalition to facilitate the implementation of the "Blufflands Plan"; and,

WHEREAS, County staff has developed "Guidelines for Requesting Blufflands Funding" to provide a consistent way for community organizations and municipalities within La Crosse County to request funding assistance for blufflands projects from the County; and,

WHEREAS, the County has received a request from the Village of Holmen for \$40,000.00 to help them complete the Southern Portion of the Holland Bluff Multi-use Trail (HBMT) paving project, and that the request follows the guidelines for requesting funding and meets all the requirements that the County has set for providing funding.

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby approves the contribution of \$40,000.00 to the Village of Holmen to assist in the construction of the southern portion of the Holland Bluff Multi-use Trail (HBMT) paving project; and,

BE IT FURTHER RESOLVED, that the County Board Chair, after approval by Corporation Counsel is hereby authorized to execute a grant agreement with the Village of Holmen to ensure that funds will be used to complete the southern portion Holland Bluff Multi-use Trail (HBMT) paving project.

FISCAL NOTE: This \$40,000.00 contribution will be paid from Account 100.130.1190.63100.00 Economic Development Bluffland Protection. That account currently has \$193,600.00 which has been budgeted in previous years and carried forward in 2025.


