 - Supervisor Scheller attended the WCA Conference and noted one highlight he took away was the need to differentiate ourselves to get people to come work and live here.

 - Supervisor Leibold also attended the WCA Conference and noted it helped connect the dots on the important work we do at the County.
 - Supervisor Cornforth attended the groundbreaking for the Skilled Workforce Center and noted just over \$10 million has been raised with a goal of \$14 million.

WHEREAS, the dedicated professionals in La Crosse County's Human Services Department and Family Court provide essential support to thousands of individuals and families each day, offering both temporary and long-term assistance to help meet basic needs and navigate life's transitions; and WHEREAS, the individuals served by these programs span all ages, from before birth to over 100 years old, reflecting the broad and critical impact of these services within our community; and **WHEREAS**, county human services programs are designed to protect and empower our most vulnerable populations, including children, individuals with disabilities, older adults, and those experiencing mental health challenges; and WHEREAS, human services professionals frequently enter homes and community spaces, often facing volatile situations and personal safety risks, to ensure that those in need receive compassionate and effective support; and **WHEREAS**, Family Court, along with Mediation and Family Court Services, plays a vital role in upholding the dignity, safety, and security of families undergoing difficult transitions; and WHEREAS, the dedication and commitment of human services and family court professionals not only transform individual lives but also strengthen the well-being and resilience of the entire community. **NOW, THEREFORE, BE IT RESOLVED** that the La Crosse County Board hereby proclaims March 2025 as Human Services and Family Court Month and encourages all residents to recognize and appreciate the invaluable contributions of these professionals in building a stronger, more supportive community.

- I Am Not Invisible Project Presentation
 - Veterans Service Officer Jane Brannan Tamboli presented the *I Am Not Invisible Project*. During the presentation, photos of the women veterans who participated were shown. Woman veterans comprise about 10% of the veteran population and many encounter obstacles in being acknowledged for their service. This campaign started as a program that include 20 photos of woman veterans from Oregon. The VA started a nationwide campaign in 2017. This is the first *I Am Not Invisible* campaign in Wisconsin. The

campaign partnered with WTC Photography program to take the photos. The unveiling ceremony reception of this campaign will be held on Thursday at 5:15pm at Western in the Coleman Center.

- Economic Development Plan Overview presented by Community Development Specialist Sam Bachmeier.
 - The purpose of the plan is to develop an understanding of La Crosse County's current economic position; to ensure a clear and consistent understanding of the role of all economic development partners; and to provide La Crosse County staff and leadership with an understanding of which economic development needs to be prioritized through annual workplans and budgeting. The planning process included gathering data, gathering stakeholder input, and internal/external analysis. Within the plan are four key pillars: business climate; education, talent and workforce; economic infrastructure; and quality of life. The next steps will be to prioritize, develop a workplan, align county programming, and develop a budget.
- County Farm Planning Update presented by the Director of Zoning, Planning and Land Information Kathleen Stewart.
 - The first sale of the County Farm was a patent in 1863 to a veteran who came home from the civil war. Twenty years later in 1886 it was transferred to the County for \$8100. Another parcel was transferred in 1900 for \$9300. The school district then was gifted or bought 97 acres. That left 224 acres to develop but with slopes, there is only 115 developable acres. The farm was initially in the Town of Hamilton but was annexed by the Village of West Salem. Ideas will be coming forward for the development of the remaining 111 acres.
- General Update
 - Administrator Klekamp announced that the Finance Department received the Government Finance Officers Association Award for Outstanding Achievement in Popular Annual Financial Reporting for the 10th year; weight restrictions signs are up on County Highways; the Health Department distributed over 1,000 doses of Narcon, concluded almost 1300 inspections of licensed facilities, supported over 2400 individuals on WIC, and provided dental care to 730 students through the Seal a Smile Program; and the Parks teams are busy getting Vets and Goose Island ready which will open on April 15th.
