fleeing persecution and violence after aiding U.S. forces during the Vietnam War; and WHEREAS, upon arrival, Hmong refugees faced profound challenges—including racism and cultural displacement—vet continued to persevere with strength, dignity, and hope; and WHEREAS, in the face of adversity, the Hmong community in Wisconsin—including La Crosse County—preserved their language and cultural identity while building thriving families, businesses, and institutions; and WHEREAS, Wisconsin is home to the third-largest Hmong population in the United States, and La Crosse County is among the counties with the highest Hmong populations in the state; and WHEREAS, La Crosse County proudly celebrates the vital contributions of Hmong Americans, including the leadership of three local Hmong-led nonprofit organizations—Vang Council of La Crosse, the Hmong Cultural and Community Center, and Cia Siab, Inc.—alongside many Hmong-owned small businesses that enrich our community; and WHEREAS, Hmong Americans continue to shape the economic, cultural, civic, and political fabric of La Crosse County and the nation, strengthening our communities with their enduring spirit and commitment to a better future for all. NOW, THEREFORE, BE IT RESOLVED, that the La Crosse County Board hereby proclaims May 14, 2025, as Hmong American Day, and invites all residents to honor and celebrate 50 years of Hmong resilience, heritage, and contributions to our shared society. Join us in recognition and celebration at the Hmong American Day gathering on Saturday, May 17, 2025, at 10 a.m. at the Onalaska Omni Center

PROCLAMATION MAY 2025 - LAW ENFORCEMENT / PUBLIC SAFETY & COURTS MONTH

WHEREAS, in a free and democratic society, law enforcement and public safety professionals are entrusted with the vital responsibility of protecting the civil rights, safety, and well-being of all residents and visitors in our community; and **WHEREAS,** La Crosse County is served by dedicated professionals across multiple departments—including the Courts, District Attorney's Office, Sheriff's Office, Emergency Management, Medical Examiner, and Public Safety Communications—who work together to uphold justice

and enhance public safety; and **WHEREAS**, thousands of individuals in La Crosse County receive essential assistance each year from these professionals, who respond to emergencies, support victims, and ensure access to fair and effective justice; **NOW**, **THEREFORE**, **BE IT RESOLVED**, that the La Crosse County Board hereby proclaims the month of May 2025 as Law Enforcement, Public Safety & Courts Month, and encourages all residents to recognize and express gratitude for the invaluable contributions of the individuals who serve to protect and strengthen our community.

- Presentation of Level III Health Department Certificate this presentation was postponed to a later meeting.
- Climate Action Plan Report presented by County Planner Dillon Constant
 - A Climate Action Plan was made following a resolution that set a carbon neutrality goal by 2050, a comp plan goal, and board strategic plan priorities of environmental stewardship and carbon reduction. The plan was staff led and data driven. Planning steps were carried out from May 2023 October 2024 that included researching best practices, having a staff advisory team, community advisory team, data collection, public engagement, summarizing conditions and findings, setting goals and recommending actions, and refinement with department head review. There are two parts to the plan; part 1 is Government Operations (internal) and part 2 is Community Sustainability (external). Key findings and goals with recommended actions were reviewed from the plan. The plan is a guide to a carbon neutral government with lowered emissions and supporting community climate resilience, builds on existing sustainability work, being proactive to lower expenses and increase efficiency, and achieving carbon neutrality.
- Strategic Plan Update presented by Administrator Klekamp.
 - The Strategic Plan was approved in August 2024 and was a five-year plan that included seven vision statements and outcome measures and four strategic directions. following list will show the progress made so far as implementation begins. Economic Growth and Vitality - a new economic development plan was presented to the board in March with implementation planned for 2026 and the board approved up to \$250,000 in airport funding. Engaged and Empowered Employees - a comprehensive wage review is underway, and the Leadership and Cultural Competencies are being embedded across the organization. Environmental Stewardship - a Climate Action Plan was presented to the board, Bostwick Creek Phase II is underway with \$600,000 in state funding for conservation, and a plan to add solar to Hillview was approved. Healthy Infrastructure -Broadband Specialists was hired to support major BEAD applications and a record \$14.1 million highway construction program launched. Inclusive Community - 21,300 individuals were connected to Medicaid and/or FoodShare, and Economic Support, Veterans Services, ADRC, and Library staff regularly attend outreach events to meet community members where they are. Robust Support Network - Pathways Home specialized unit at Human Services has been established and staffed with 133 households from the Pathways to Housing list being housed, and the Hillview project is on track and on budget for early 2026 launch and will expand our support network. Sustainable and Affordable Housing countywide housing study has started, Thriving Families program has 12 units of housing available that are all occupied with at-risk families, and the County Farm appraisal is underway to inform next steps for possible housing development. Four strategic directions are identified in the plan to focus work, resources and decision making. continuous improvement, data driven decision making, exceptional communication, and invest in staff and grow future leaders. The Strategic Plan is becoming part of how the County works and is helping to keep us focused, aligned and accountable to the long-term goals.
