RE: TRANSFER OF PROPERTY TO CITY OF ONALASKA (OLD CTH OS)

WHEREAS, between 1999 and 2001, La Crosse County transferred jurisdiction of Old County Highway OS and SS to the City of Onalaska; and,

WHEREAS, it has come to the attention of the County and the City that a parcel of land that was part of Old County Highway OS and is now part of the City's East Main Street was missed in the transfer of land and is still recorded as being owned by the County; and

WHEREAS, this property is more specifically described as:

Outlot 1, Volume 3 CSM, page 22 at document number 958093 as recorded in the La Crosse County Register of Deeds Office, being part of the NW1/4, Section 10, T16N, R7W, Town of Medary, La Crosse County, Wisconsin excepting therefrom that portion of said Outlot 1 lying North of the North right-of-way line of CTH OS as shown on said Volume 3, CSM, Page 22

NOW THEREFORE BE IT RESOLVED, that the La Crosse County Board hereby authorizes the transfer of property as identified above to the City of Onalaska;

BE IT FURTHER RESOLVED, that, following approval by Corporation Counsel, the County Board Chair and County Clerk are hereby authorized to execute any and all documents to effectuate such transfer.
