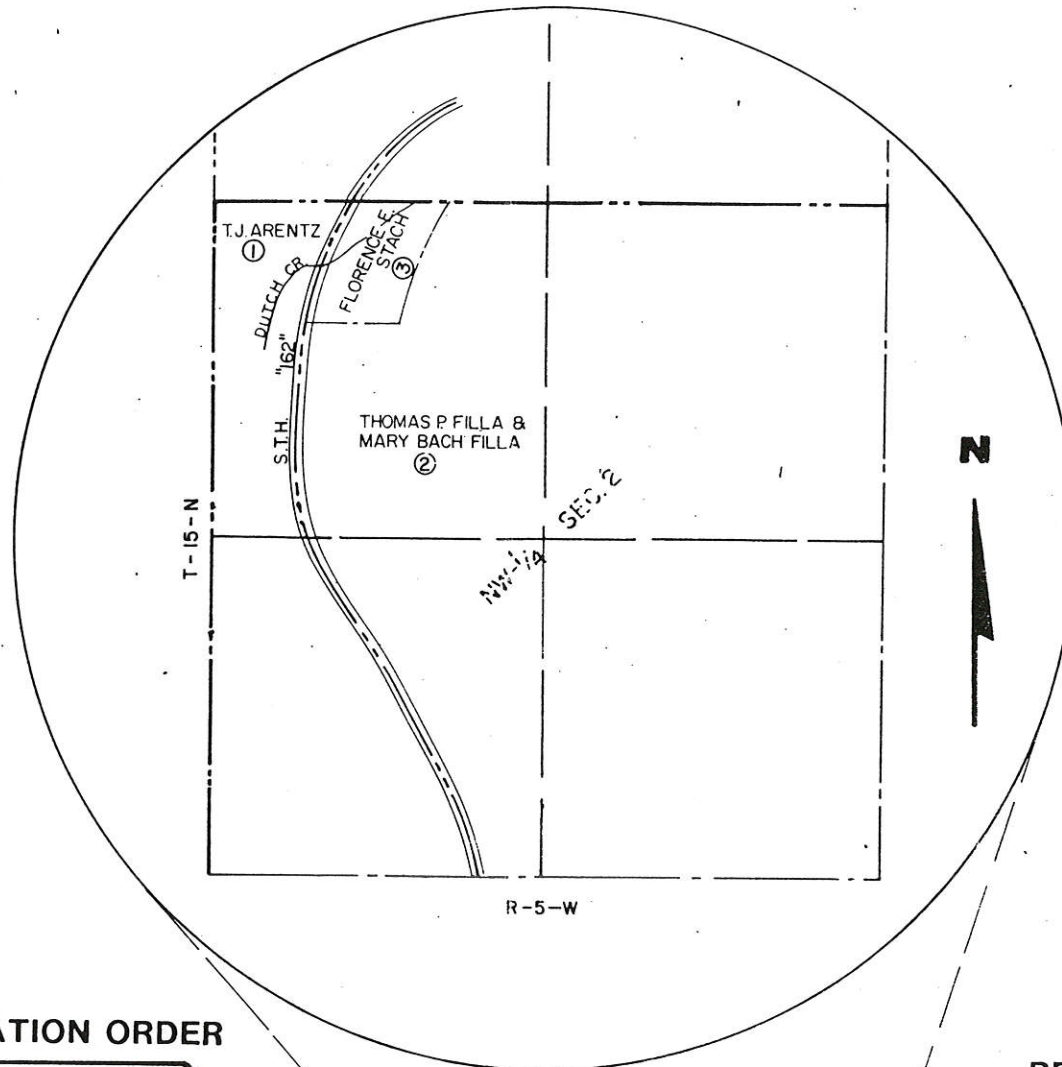
N 1/4 CORNER OF SECTION 2

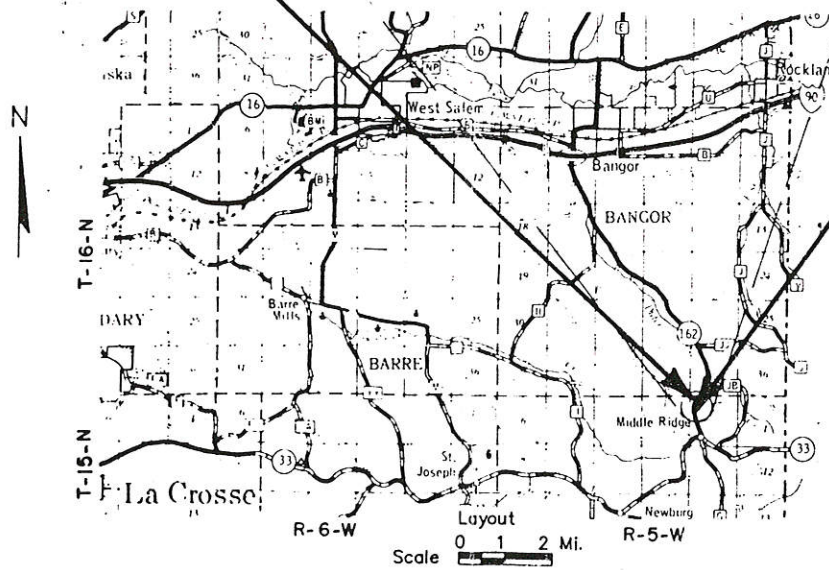

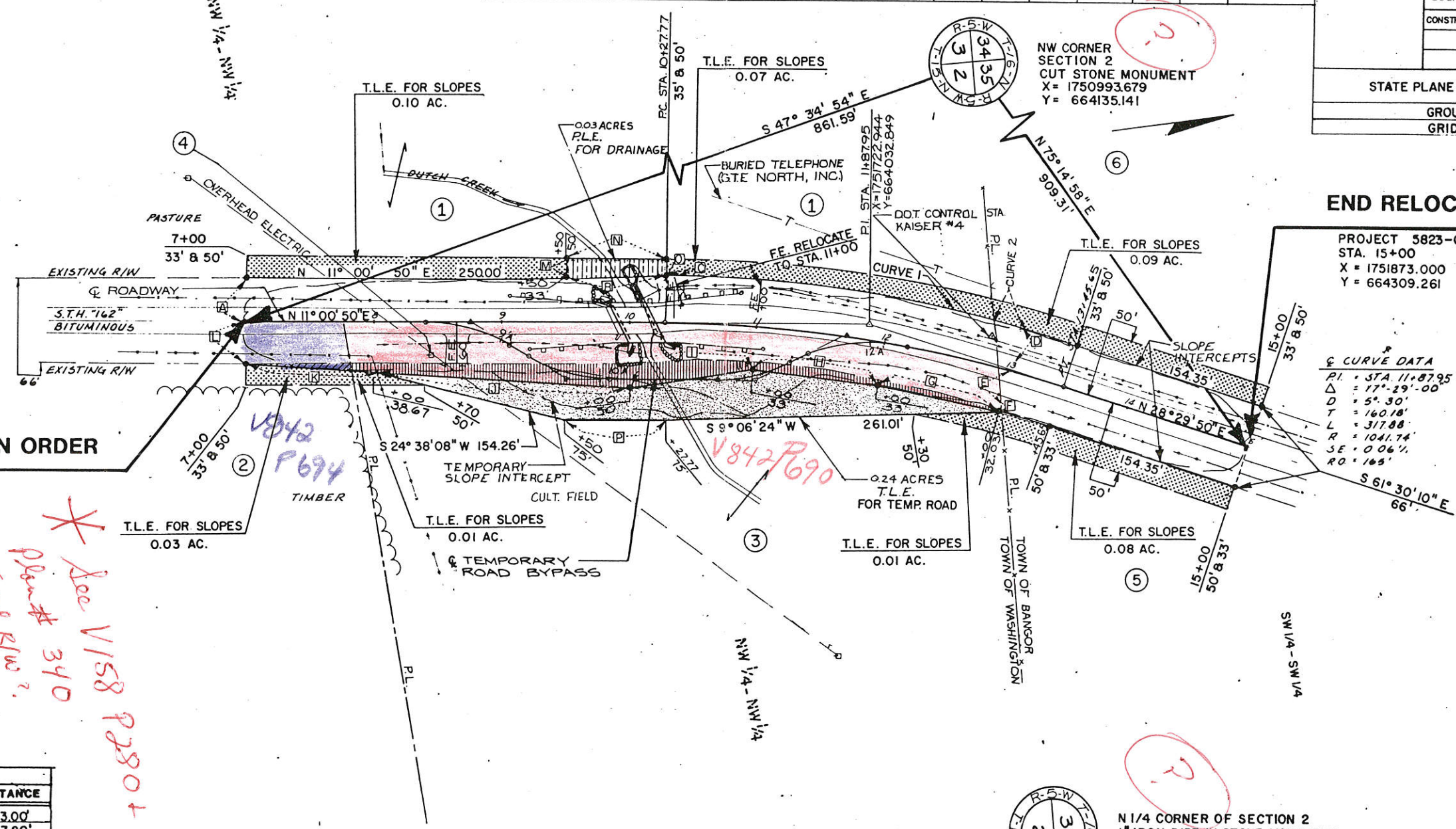

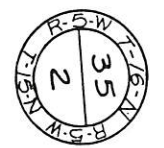
