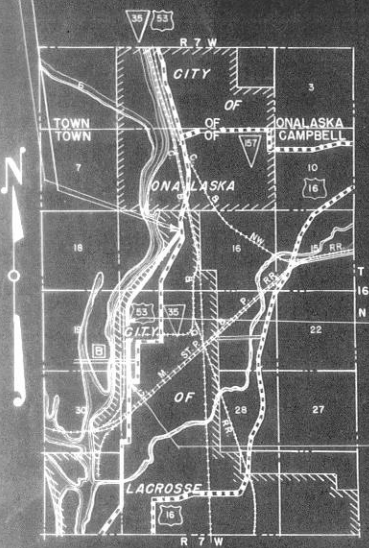

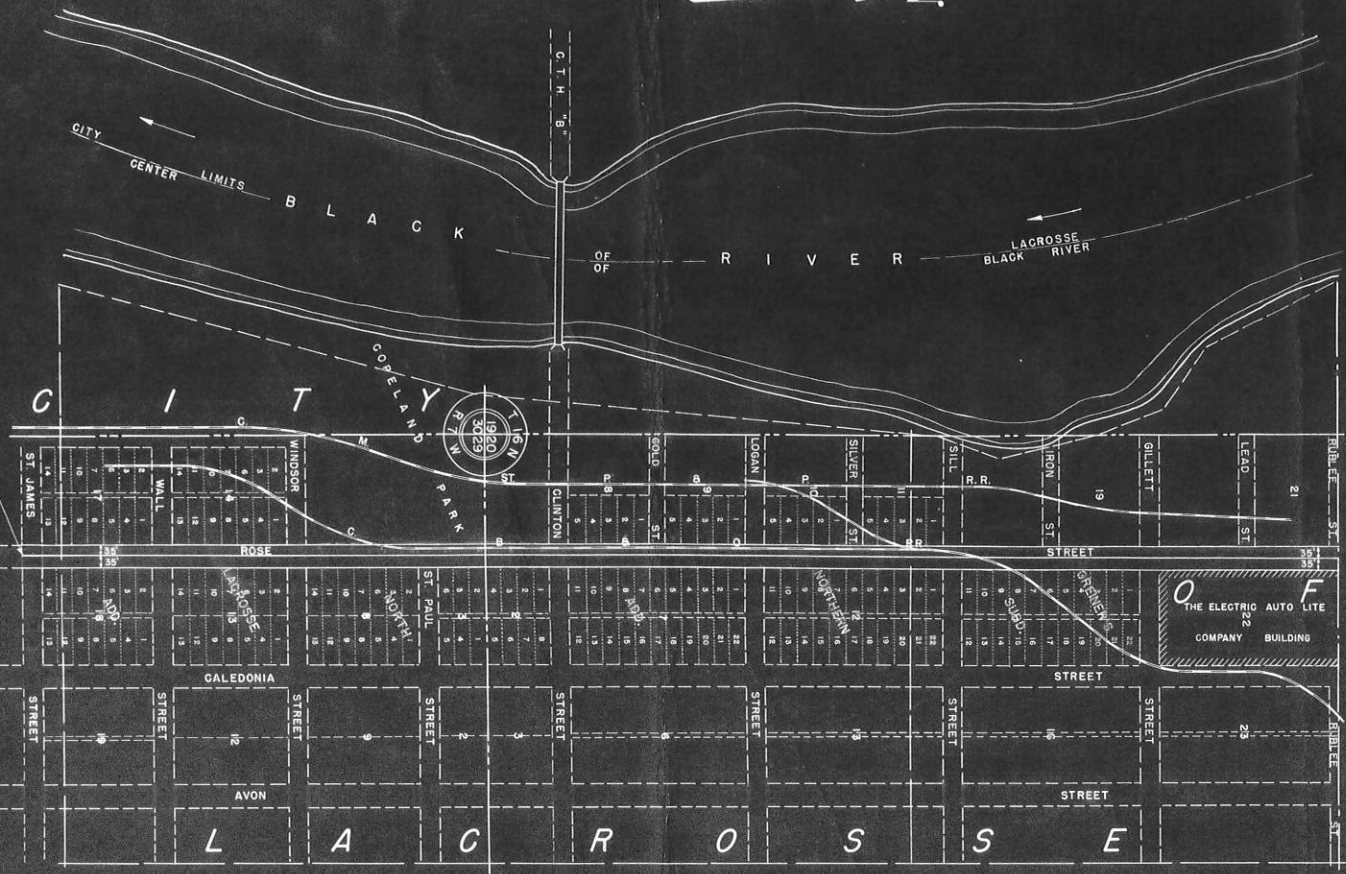


STA 0+33

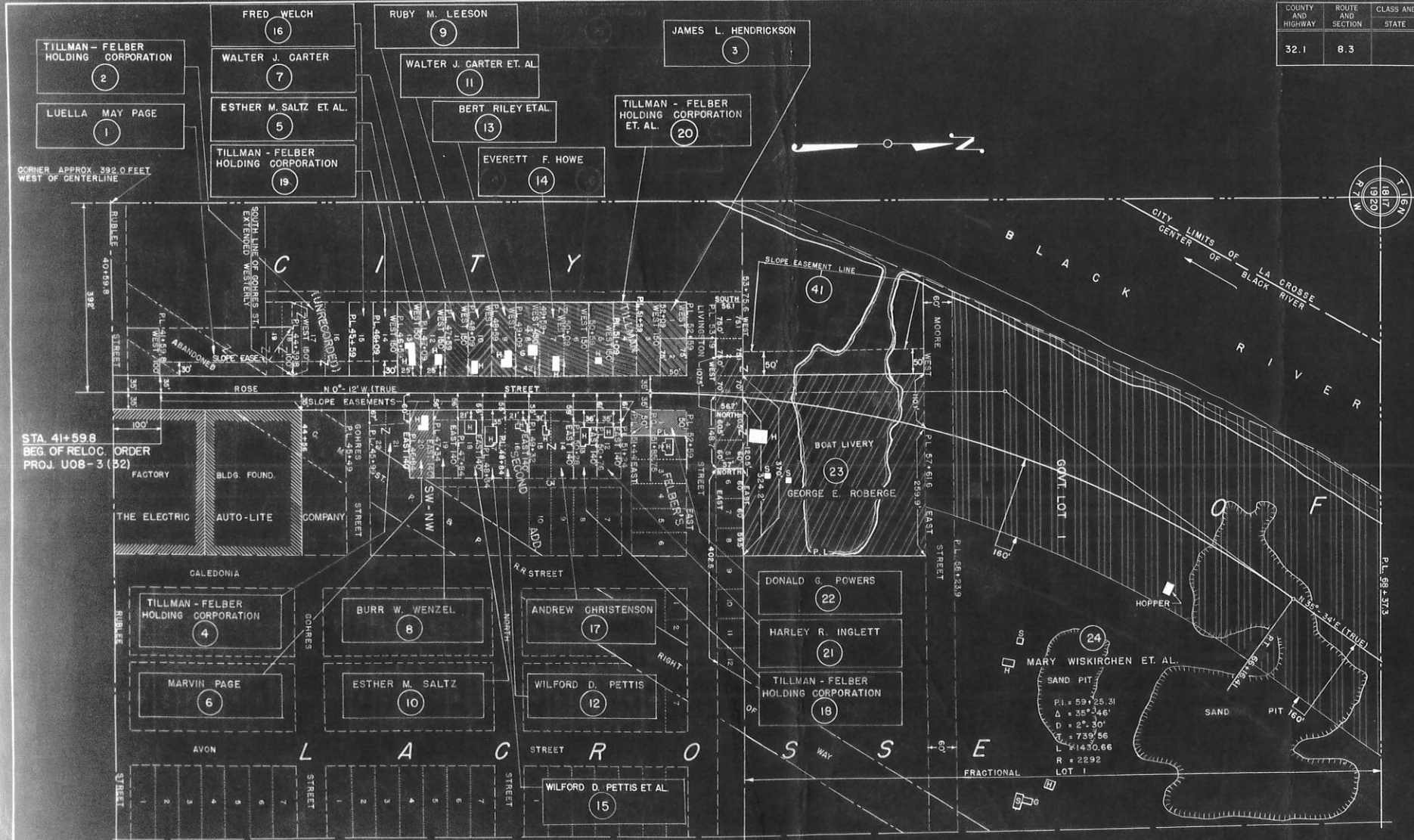

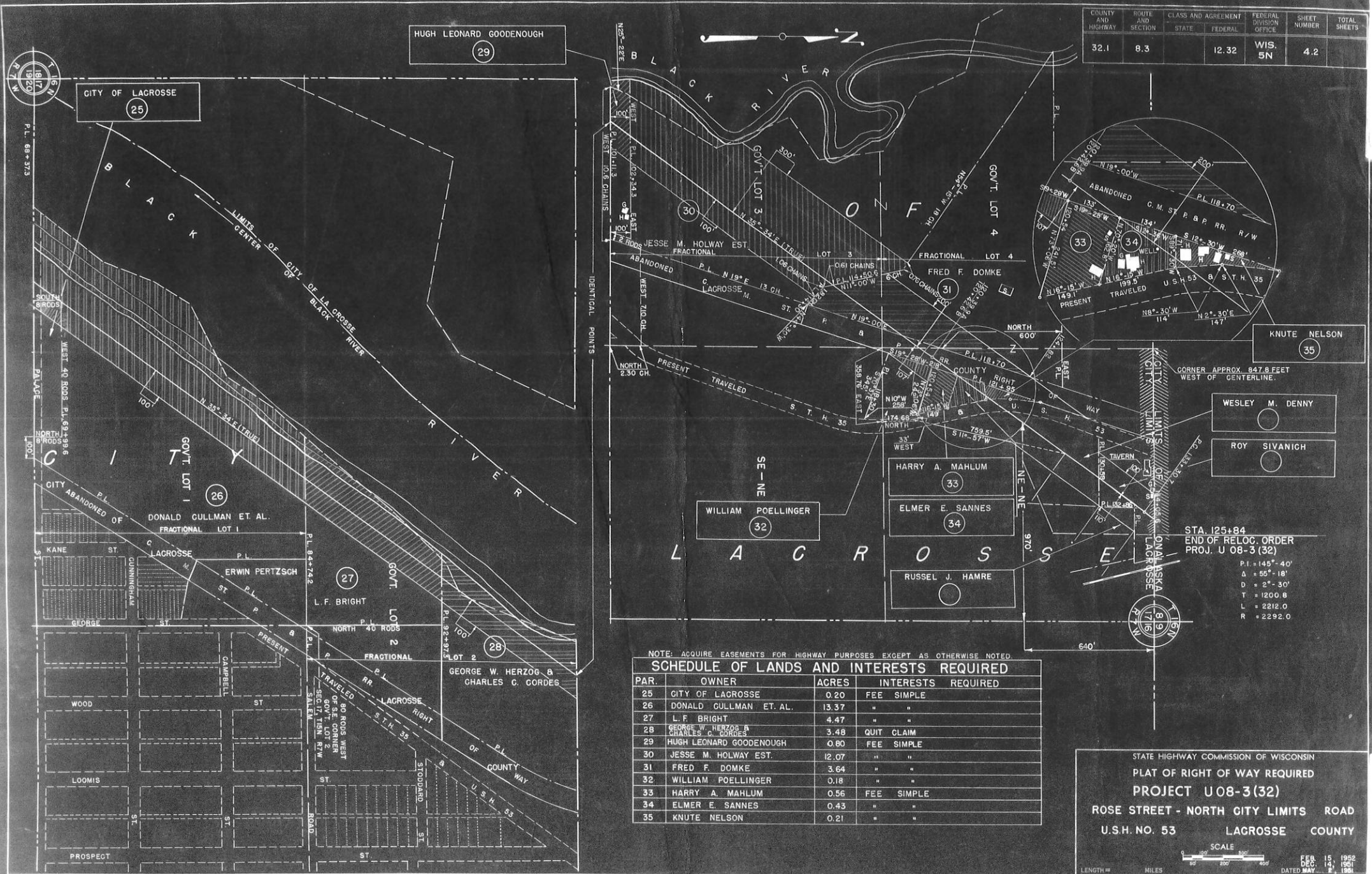
