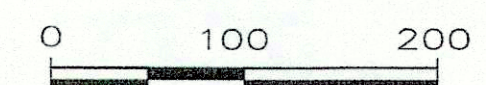
RELOCATION ORDER STH 162, LAX-CASHTON / STH 33-DUTCH CREEK BR, LA CROSSE COUNTY

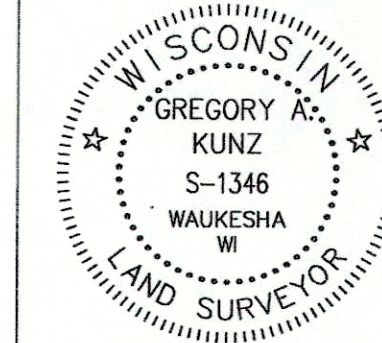

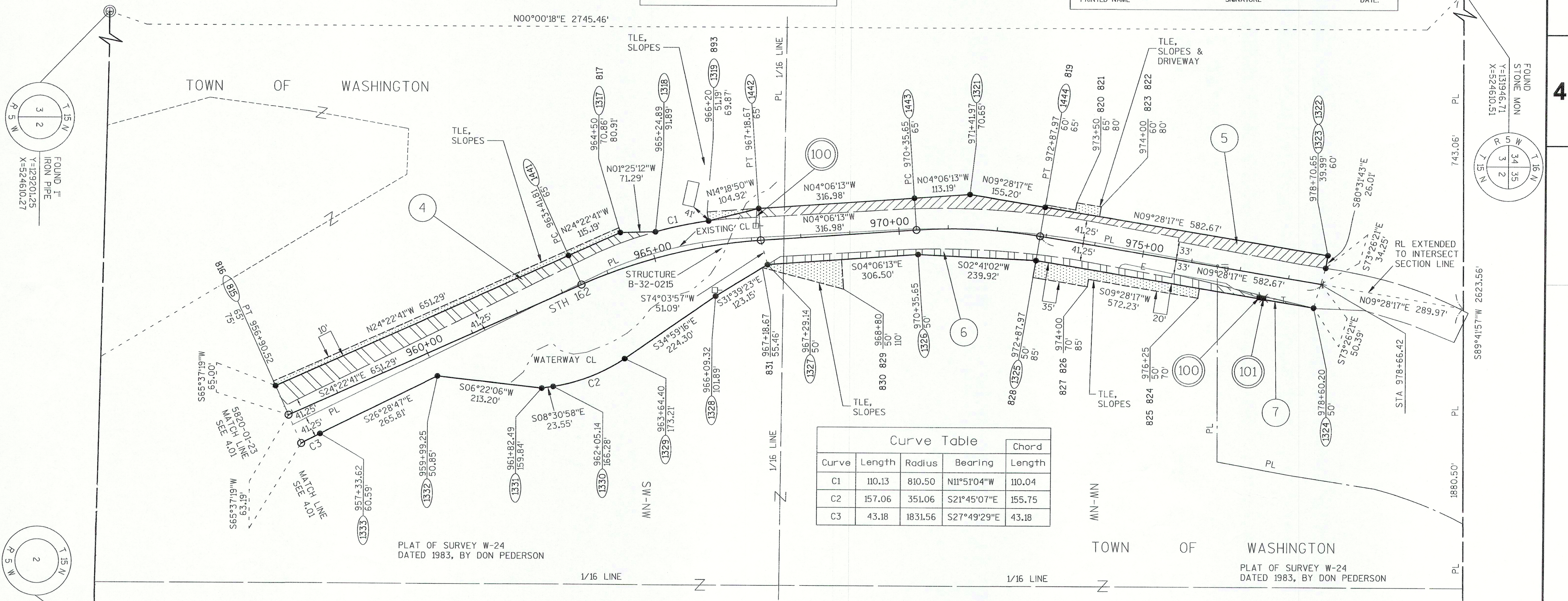
