Description of termini of project:

Beginning at a point APPROXIMATELY 1206 feet south of and 133 feet west of the East 1/4 Corner of Section 5, T-15-N, R-6-W, thence northerly for APPROXIMATELY 445 feet to a point APPROXIMATELY 868 feet south of and 414 feet west of the East 1/4 Corner of said Section 5, T-15-N, R-6-W, all in the Town of Greenfield, La Crosse County, as shown on the attached easement exhibit.

To properly establish, lay out, widen, enlarge, extend, construct, reconstruct, improve, or maintain a portion of the highway designated above, it is necessary to relocate or change and acquire certain lands or interests in lands as shown on the right of way plat for the above project.

To effect this change, pursuant to authority granted under Sections 83.07 and 83.08, Wisconsin Statutes, the La Crosse County orders that:

1. The said road is laid out and established to the lines and widths as shown on the plat.
2. The required lands or interests in lands as shown on the plat shall be acquired by: La Crosse County
3. This order supersedes and amends any previous order issued by the: La Crosse County

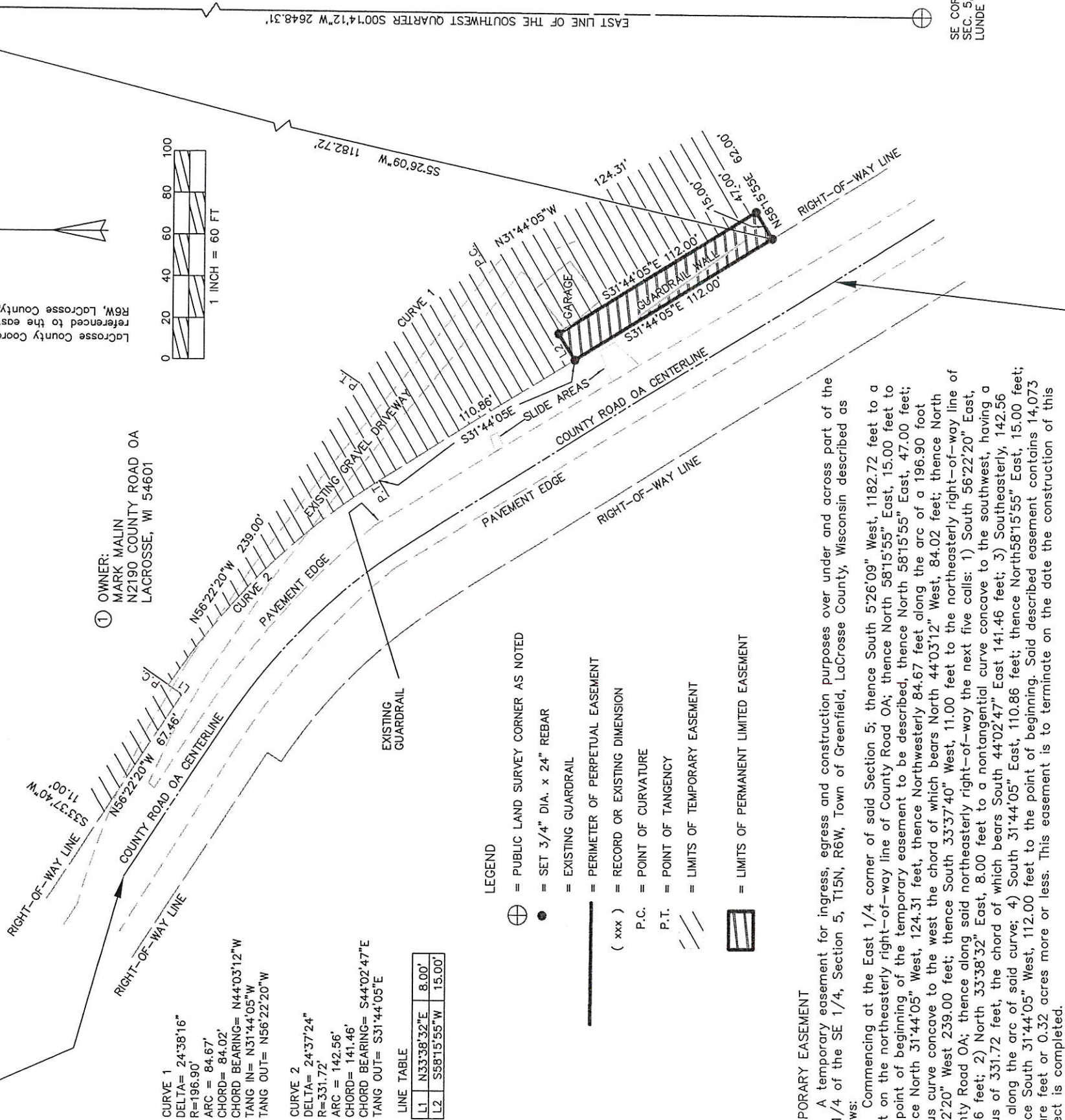

TEMPORARY EASEMENT

A temporary easement for ingress, egress and construction purposes over under and across part of the NE 1/4 of the SE 1/4, Section 5, T15N, R6W, Town of Greenfield, LaCrosse County, Wisconsin described as follows:  
Commencing at the East 1/4 corner of said Section 5; thence South 5°26'09" West, 1182.72 feet to a point on the northeasterly right-of-way line of County Road OA; thence North 58°15'55" East, 15.00 feet to the point of beginning of the temporary easement to be described, thence North 58°15'55" East, 47.00 feet; thence North 31°44'05" West, 124.31 feet, thence Northwesterly 84.67 feet along the arc of a 196.90 foot radius curve concave to the west the chord of which bears North 44°03'12" West, 84.02 feet; thence North 56°22'20" West 239.00 feet; thence South 33°37'40" West, 11.00 feet to the northeasterly right-of-way line of County Road OA; thence along said northeasterly right-of-way the next five calls: 1) South 56°22'20" East, 67.46 feet; 2) North 33°38'32" East, 8.00 feet to a nontangential curve concave to the southwest, having a radius of 331.72 feet, the chord of which bears South 44°02'47" East 141.46 feet; 3) Southeasterly, 142.56 feet along the arc of said curve; 4) South 31°44'05" East, 110.86 feet; thence North 58°15'55" East, 15.00 feet; thence South 31°44'05" West, 112.00 feet to the point of beginning. Said described easement contains 14,073 square feet or 0.32 acres more or less. This easement is to terminate on the date the construction of this project is completed.

PERMANENT LIMITED EASEMENT

A permanent limited easement for retaining wall maintenance and for erosion and stormwater control purposes over, under and across part of the NE 1/4 of the SE 1/4, Section 5, T15N, R6W, Town of Greenfield, LaCrosse County, Wisconsin described as follows:  
Commencing at the East 1/4 corner of said Section 5; thence South 5°26'09" West, 1182.72 feet to a point on the northeasterly right-of-way line of County Road OA and the point of beginning of the easement to be described; thence North 58°15'55" East, 15.00 feet; thence North 31°44'05" West, 112.00 feet; thence South 58°15'55" West, 15.00 feet to the northeasterly right-of-way line of County Road OA; thence South 31°44'05" East, 112.00 feet to the point of beginning. Said described easement contains 1,680 square feet or 0.03 acres more or less.

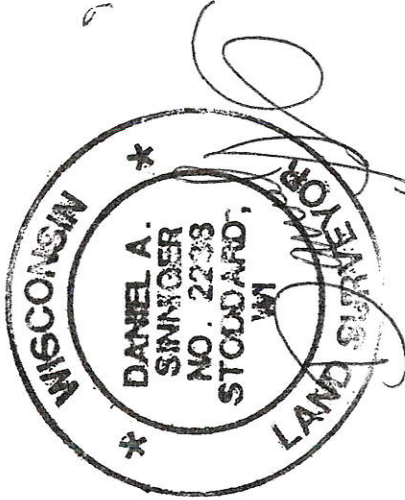

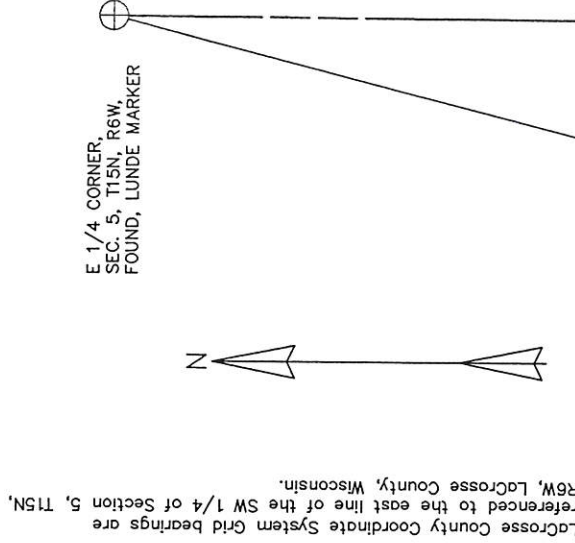
