
## SERTIFIED SURVEY MAP

Description:

A parcel of land located in the NE4 of the NE4 of Section 20, T15N -R5W, Town of Washington, LaCrosse County, Wisconsin, described as follows: Commencing at the Northeast corner of said Section 20; thence S 18 44'03"W, 893.30 feet to the point of beginning; thence S 01 23'55"W, 208.77 feet; thence N 88 35'57"W, 208.64 feet; thence N 01 23'52"E, 208.80 feet; thence S 88 35'27"E, 208.64 feet to the point of beginning, containing one (1) acre of land. Together with a 20 ft. wide driveway access easement to be used for ingress and eggess to said one acre, the centerline of said to be used for ingress and egress to said one acre, the centerline of said easement described as follows: commencing at the Southeast corner of aforesaid described one acre parcel; thence N 88 35'57"W, 10 feet to the point of beginning of the centerline of said 20 ft. wide easement; thence S 02 05'52"W, 18.20 feet along said centerline; thence S 86 37'13"E, 119.99 feet along said centerline; thence S 39 08'18"E, 41.35 feet along said centerline; thence S 11 23'45"E, 77.92 feet along said centerline to a point on the West right-of-way line of State Highway "162", said point being the termination of said centerline. Said 20 ft. easement shall be measured at 10 feet and at right angles from each side of the previously described centerline.
