
## PLAT OF SURVEY

## DESCRIPTION:

A parcel of land located in part of the NW4-NE% of Section 24, T15N-R5W, Town of Washington, LaCrosse County, Wisconsin, described as follows: Commencing at the N¼ corner of said Section 24; thence SO°06'26"W along the West line of said NW4-NE¼ 68.76 feet to the centerline of Muenzenberger Road, also, being the point of beginning; thence Southeasterly along the centerline of said Road, on a curve concave to the Southeast, having a radius of 224.83 feet (Long Chord bears S54°36'22"E, 51.24 feet), an arc distance of 51.35 feet; thence S48°03'48"E along the centerline of said Road 52.84 feet; thence Southeasterly along the centerline of said Road, on a curve concave to the Northeast, having a radius of 200.15 feet (Long Chord bears S67°20'25"E, 132.15 feet), an arc distance of 134.68 feet; thence S86°37'02"E along the centerline of said Road 119.99 feet; thence Easterly along the centerline of said Road, on a curve concave to the North, having a radius of 831.08 feet (Long Chord bears N86°31'18"E, 198.57 feet), an arc distance of 199.04 feet; thence N79°39'38"E along the centerline of said Road 493.54 feet; thence N82°22'33"E along the centerline of said Road 223.12 feet; thence N78°26'18"E along the centerline of said Muenzenberger Road 82.90 feet to the East line of said NW4-NEX; thence S0°14'00"W, 1280.32 feet to the SE corner of said NW4-NEX; thence N89°44'44"W, 1306.03 feet to the SW corner of said NW4-NE4; thence NO°O6'26"E along the West line of said NW4-NE4 1250.65 feet to the point of beginning.
