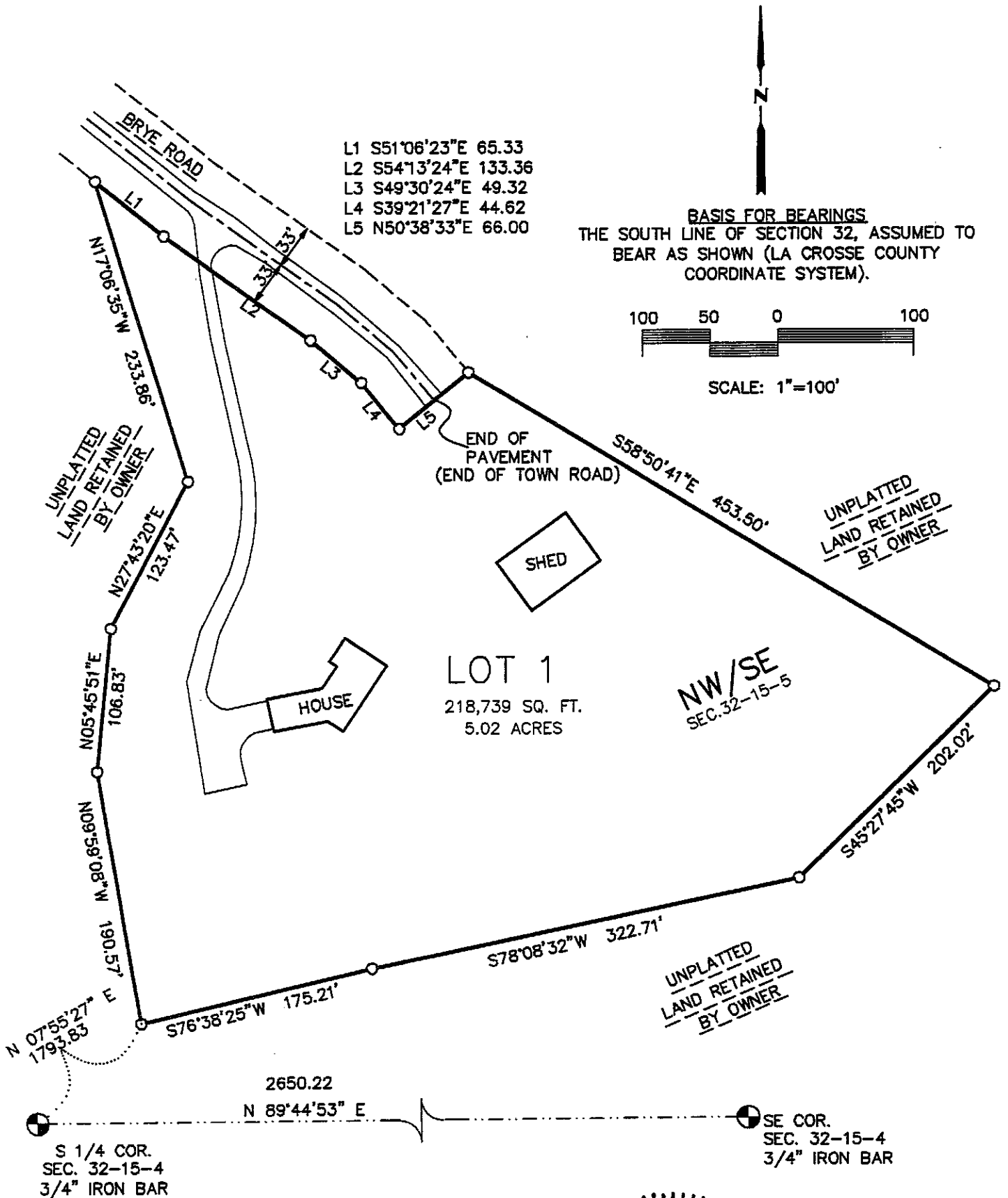

TOWN OF WASHINGTON, LA CROSSE COUNTY, WISCONSIN.

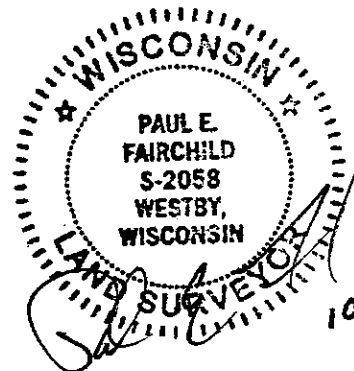

PART OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 32, T15N, T5W, TOWN OF WASHINGTON, LA CROSSE COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTH QUARTER CORNER OF SAID SECTION 32; THENCE N7°55'27"E 1793.83 FEET TO THE POINT OF BEGINNING; THENCE N09°59'08"W 190.57 FEET; THENCE N05°45'51"E 106.83 FEET; THENCE N27°43'20"E 123.47 FEET; THENCE N17°06'35"W 233.86 FEET TO THE SOUTHERLY RIGHT OF WAY LINE OF BRYE ROAD; THENCE ALONG SAID SOUTHERLY RIGHT OF WAY LINE THE NEXT FOUR CALLS: 1) S51°06'23"E 65.33 FEET; 2) S54°13'24"E 133.36; 3) S49°30'24"E 49.32 FEET; 4) S39°21'27"E 44.62 FEET TO THE TERMINUS OF SAID BRYE ROAD; THENCE ALONG SAID TERMINUS LINE, N50°38'33"E 66.00 FEET; THENCE S58°50'41"E 453.50 FEET; THENCE S45°27'45"W 202.02 FEET; THENCE S78°08'32"W 322.71 FEET; THENCE S76°38'25"W 175.21 FEET TO THE POINT OF BEGINNING.
