

I set this corner in the old occupied North-South line and 66 feet North of the old fence corner to the South. This fits the old occupation and deed calls. Section measurements confirmed this location. Mr. Urbanek said that the fence corner to the South was rebuilt where the old one was and they always assumed it to be 4 rods South of the section corner. I set an iron bar with a cap at the corner.


